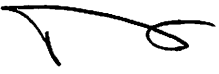

I, Scott Lewis, of the City of London in the County of Middlesex, **MAKE OATH AND SAY AS FOLLOWS:**

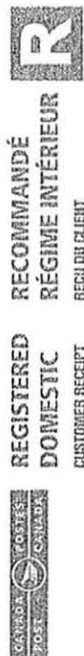
1. I am an authorized representative of OM Limited Partnership ("OMLP") and as such have knowledge of the matters to which I hereinafter depose.

I served The Corporation of the County of Norfolk with the Notice of Hearing for OMLP's application for the approval of a natural gas franchise agreement with the Corporation of Norfolk County which would grant to OM Limited Partnership the right to construct and operate works for the distribution, transmission and storage of natural gas and the right to extend and add to the works for a period of 20 years, together with an order directing and declaring that the assent of the municipal electors of the Corporation of Norfolk County is not required in relation to the natural gas franchise agreement.

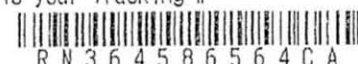

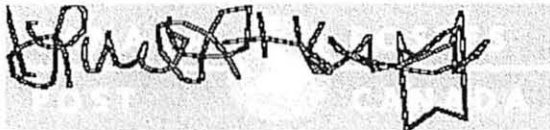
