

Enbridge Gas Inc.

**Application for leave to construct natural gas transmission pipeline
and associated facilities in the Municipality of Chatham-Kent**

PROCEDURAL ORDER NO. 1

April 17, 2019

Enbridge Gas Inc. (Enbridge Gas) applied to the Ontario Energy Board (OEB) under sections 90(1) and 97 of the *Ontario Energy Board Act, 1998* for leave to construct approximately 13.5 kilometres of natural gas transmission pipeline in the Municipality of Chatham-Kent and approval of the form of temporary land use agreement related to the construction of the proposed pipeline.

The OEB issued a Notice of Hearing on March 28, 2019. Anwaatin Inc. (Anwaatin) applied for intervenor status and cost eligibility. No objection was received from Enbridge Gas. By letter dated April 16, 2019, the OEB informed Anwaatin that it required additional information in relation to its request. The OEB will consider Anwaatin's intervention request and cost eligibility when the required information is filed.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. Parties shall request any information and material from Enbridge Gas that is in addition to Enbridge Gas' evidence and that is relevant to the hearing by written interrogatories filed with the OEB and delivered to Enbridge Gas by **April 26, 2019**.
2. Enbridge Gas shall file with the OEB and deliver to all parties complete written responses to all interrogatories by **May 10, 2019**.
3. Unless the OEB orders otherwise, parties may file any written submission with the OEB and serve them on Enbridge Gas by **May 24, 2019**.

4. Unless the OEB orders otherwise, Enbridge Gas may file a written reply submission with the OEB and serve it on all parties by **May 31, 2019**.

All filings to the Board must quote the file number, EB-2018-0188 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a USB flash drive in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
