

Enbridge Gas Inc.

**Application for leave to construct natural gas pipelines and
associated facilities to serve the Georgian Sands planned
subdivision in Simcoe County**

PROCEDURAL ORDER NO. 1

April 25, 2019

Enbridge Gas Inc. (Enbridge Gas) applied to the Ontario Energy Board (OEB) under sections 90(1) and 97 of the *Ontario Energy Board Act, 1998* for leave to construct approximately 8 metres of Extra High Pressure and approximately 6.4 kilometres of Intermediate Pressure natural gas pipelines and associated facilities to serve the Georgian Sands planned subdivision in Simcoe County. Enbridge Gas has also applied to the OEB for approval of the form of land use agreements related to the construction of the proposed project.

The OEB issued a Notice of Hearing on March 27, 2019. Anwaatin Inc. (Anwaatin) applied for intervenor status and cost eligibility. No objection was received from Enbridge Gas. Anwaatin is approved as intervenor and is eligible to apply for an award of costs under the OEB's *Practice Direction on Cost Awards*. The list of parties in this proceeding is attached as Schedule A to this procedural order.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. OEB staff and Anwaatin shall request any information and material from Enbridge Gas that is in addition to Enbridge Gas' evidence and that is relevant to the hearing by written interrogatories filed with the OEB and delivered to Enbridge Gas by **May 9, 2019**.
2. Enbridge Gas shall file with the OEB and deliver to all parties complete written responses to all interrogatories by **May 23, 2019**.

All filings to the OEB must quote the file number, EB-2018-0226 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a USB flash drive in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
