Energy Probe Intervenor Request Letter**

Energy Probe Research Foundation (Energy Probe) applies for intervenor status in the EB-2019-0082 proceeding, the application by Hydro One Networks Inc. to the Ontario Energy Board for an order or orders for approval of electricity transmission rates for the 2020 to 2022 period.

Statement of Interest

Energy Probe is a non-profit environmental and consumer organization which promotes economic efficiency in the use of resources. Energy Probe will be representing its electricity residential customer supporters in Ontario, which we have some number of thousands, and will also be representing a broader concern with respect to the overall financial health and operational integrity of Ontario utilities. Energy Probe was an active participant in past Hydro One Transmission proceedings and hopes that its participation will be of assistance to the Board.

Energy Probe expects that it will focus on the following parts of the application:

- the proposed revenue requirement for 2020 and its recovery in rates,
- the proposed custom IR plan for setting rates for 2012 and 2022,
- the proposed Transmission System Plan, and the Capital Performance Report,
- the Transmission Scorecard including reliability performance,
- OM&A expenditures including Common Corporate Costs and management compensation.
