ENWIN Utilities Ltd. Application for Approval of Distribution Rates and
Other Charges Effective January 1, 2020 (the “Application”)**

We have been retained as counsel to ENWIN Utilities Ltd. in respect of the above noted matter.

Please find enclosed an electronic copy of the Application, which has been prepared as a rebasing application in accordance with the Board’s 4th Generation Incentive Rate-setting method on a forward test-year cost of service basis.

Two original hard copies of the Application will follow by courier under separate cover.

Confidentiality Claim

As part of the Application, ENWIN Utilities Ltd. (“ENWIN”) is filing a redacted version of ENWIN’s 2017 Federal and Provincial Tax Return (“**Tax Return**”), which is being filed in confidence pursuant to Section 4.3 of the Ontario Energy Board’s (the “**Board**”) Practice Direction on Confidential Filings (the “**Practice Direction**”).

Section 4.3.1 of the Practice Direction states:

“Subject to limited exceptions, the Board is prohibited from releasing personal information, as that phrase is defined in FIPPA. When a person files a document or record that contains the personal information of another person who is not a party to the proceeding, the person

filing the document or record must file two versions of the document or record in accordance with Rule 9A.01 of the Board's Rules of Practice and Procedure.”

The redacted information in the Tax Return includes personal information, such as names of individuals (employees' names and apprentices' names) and associated personal information. ENWIN does not have these individuals' consent to disclose this information.

The Practice Direction recognizes that this is among the factors that the Board will take into consideration when addressing the confidentiality of filings.

In keeping with the requirements of the Practice Direction, ENWIN is filing two confidential unredacted versions of the Tax Return in hard copy only.

The unredacted versions of the Tax Return have been placed in a sealed envelope marked “Confidential”. These documents are marked “Confidential”, and ENWIN has identified the portions of the documents in respect of which confidentiality is claimed through the use of sidebars (“f”) and printed on yellow paper. ENWIN requests that the unredacted documents be kept confidential.
