

Enbridge Gas Inc.

**Application for approval to continue the existing
financial terms associated with offering Open Bill
Access services for the years 2019 and 2020, and the
extent to which the Open Bill Access Program should
continue**

**Decision on Intervention Request
May 1, 2019**

Enbridge Gas Inc. (Enbridge Gas) filed an application with the Ontario Energy Board (OEB) on December 4, 2018 under section 36 of the *Ontario Energy Board Act, 1998*, for approval to continue the existing financial terms associated with offering Open Bill Access (OBA) services for 2019 and 2020.

The OEB issued a Notice of Hearing on December 20, 2018. In Procedural Order No. 1 and No. 2, the OEB granted Building Owners and Managers Association, Canadian Manufacturers and Exporters, Enercare Inc., HVAC Coalition, and Industrial Gas Users Association intervenor status.

Enbridge Gas and the intervenors filed, and the OEB accepted, a partial settlement proposal which proposed the scope of the matters considered in this application should include the question of whether the OBA program should continue.

The OEB issued a supplementary Notice of Hearing on April 4, 2019, through a Decision and Procedural Order No. 4 (PO4). The last date for intervention was April 18, 2019. On April 19, 2019 Energy Probe, Reliance, Simply Group, Summitt, and Vista were approved as intervenors. Home Trust Company (Home Trust) had filed a request for intervention which was inadvertently missed. No objection was received from Enbridge Gas.

Home Trust is approved as an intervenor. An updated list of intervenors in this proceeding is attached as Schedule A to this Decision

Provisions were made in PO4 for a number of procedural steps, including an opportunity for approved intervenors to file a proposal for the continuation of the Bill Insert program by April 25, 2019. Home Trust has indicated it did not plan to file such a proposal, therefore all procedural steps remain as per PO4.
