ÉCRITES OU ORALES" remove the bold and bracketed words "[l'entreprise insérera la date réelle, 10 jours suivant la date à laquelle l'avis est publié sur le site Web du demandeur]"; and

- c. In each of the English and the French version of the Notice, insert the same date which shall be determined by adding 10 calendar days to the date that the Notice will be posted on Hydro One Networks' website in accordance with the requirements of paragraph 4 below. If that date falls on a "holiday" as defined in Rule 6.02 of the OEB's *Rules of Practice and Procedure*, insert the next date that is not a holiday. Use the following date format "January 1, 2019" for the English Notice and the following date format for the French Notice "1 janvier 2019".
- 2. Once the requirements of paragraph 1 are completed, to immediately and prior to completing any other steps required in this letter of direction, file with the OEB a pdf version of the complete Notice (Dated Notice).
- 3. No later than the date the Notice is posted on Hydro One Networks' website in accordance with paragraph 4, to serve a copy of each of the English and French versions of the Dated Notice, the application and the evidence, directly on all intervenors approved in the Supply to Essex County Transmission Reinforcement project proceeding EB-2013-0421, namely: Association of Major Power Consumers in Ontario, Brantford Power Inc., Building Owners and Managers Association Toronto, Canadian Manufacturers & Exporters, Coalition of Large Distributors (consists of Alectra Utilities Inc., Hydro Ottawa Limited, Toronto Hydro-Electric System Limited and Elexicon Energy Inc.), Comber Wind Limited Partnership, Consumer Council of Canada, E3 Coalition (consists of E.L.K Energy Inc., Entegrus Powerlines Inc. and Essex Powerlines Corporation), Electricity Distributors Association, Energy Probe Research Foundation, Enwin Utilities Ltd., Independent Electricity System Operator, Innpower Corporation, London Property Management Association, Oakville Hydro Electricity Distribution Inc., Power Workers' Union, School Energy Coalition, Toyota Motor Manufacturing Canada Inc., and Wataynikaneyap Power Corporation.
- 4. To make a copy of both the English and French versions of the Dated Notice, the application and the evidence, and any amendments thereto, available for public review at Hydro One Networks' office and in a prominent place on Hydro One Networks' website.
- 5. To file with the OEB an affidavit in both electronic and paper forms proving

completion of the matters in paragraphs 3 and 4 above immediately thereafter.

6. To provide a copy of the Dated Notice, the application and the evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Dated Notice other than documents or materials expressly required by this letter of direction to be served.
