Application for certificate of public convenience and necessity to construct facilities and supply natural gas to the new New Leaf Canada Inc. Walsh Facility located in Norfolk County, Ontario

PROCEDURAL ORDER NO. 1

May 13, 2019

Metalore Resources Limited (Metalore) filed an application with the Ontario Energy Board (OEB) on February 7, 2019 under section 8 of the *Municipal Franchises Act, 1990* for an order granting Metalore a certificate of public convenience and necessity to construct facilities and supply natural gas to the new New Leaf Canada Inc. Walsh facility located on the south half of Lot 16, Concession 5, Norfolk County.

The OEB issued a Notice of Hearing on February 28, 2019. The last date for intervention was March 18, 2019. Pursuant to the Notice of Hearing, Enbridge Gas Inc. (Enbridge Gas) and ON-Energy Corp. (ON-Energy) applied for intervenor status. No objection was received from Metalore.

Enbridge Gas and ON-Energy are approved as intervenors. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

On April 11, 2019, Metalore submitted a request in writing to delay the proceeding. On April 30, 2019, Metalore submitted a request in writing to continue the proceeding.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

- Intervenors and OEB staff shall request any relevant information and documentation from Metalore that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on Metalore by May 23, 2019.
- 2. Metalore shall file with the OEB complete responses to all interrogatories and serve them on intervenors by **June 3, 2019.**
- 3. Unless the OEB orders otherwise, intervenors and OEB staff may file any written submission with the OEB and serve them on Metalore by **June 13**, **2019**.
- 4. Unless the OEB orders otherwise, Metalore may file a written reply submission with the OEB and serve it on intervenors by **June 24, 2019**.

All filings to the OEB must quote the file number, EB-2019-0089 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <u>https://pes.ontarioenergyboard.ca/eservice/</u>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <u>https://www.oeb.ca/industry</u>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
