NOTICE OF INTERVENTION AND REQUEST FOR COST ELIGIBILITY

OF THE

GREEN ENERGY COALITION (GEC)

1. The Green Energy Coalition ("GEC") hereby applies for intervenor status and cost eligibility in this proceeding.
2. The GEC is comprised of non-profit environmental organizations active on energy policy in Ontario. GEC has been an active intervenor before the Board in past DSM proceedings and has taken a lead role in the Board's various DSM related processes that have supported DSM delivery and accountability in Ontario.
3. GEC has been found eligible for costs in numerous past proceedings. No other funding for the proposed intervention is available.
4. GEC proposes to retain the research and case management services of Mr. Kai Millyard, the legal services of Mr. David Poch and the expert advice of Mr. Chris Neme. Mr. Neme has appeared before the Board as an expert on utility conservation programs and regulation in several matters. GEC will confer with other intervenors before determining whether Mr. Neme's efforts can be co-sponsored in this phase or in subsequent phases. GEC anticipates that it will be Mr. Neme who participates on June 13th.


