LETTER OF DIRECTION

Dear Ms. Lindop:

**Re: Upper Canada Transmission, Inc. (operating as NextBridge Infrastructure)
East-West Tie Project – Expropriation Application
Ontario Energy Board File Number: EB-2019-0127**

On April 17, 2019, Upper Canada Transmission, Inc. (operating as NextBridge Infrastructure) (NextBridge) applied to the Ontario Energy Board (OEB) under s. 99 of the *Ontario Energy Board Act, 1998* for an order granting authority to expropriate certain interests in lands to construct East-West Tie Project (Expropriation Application).

The OEB has issued its Notice of Application (Notice) with respect to the Expropriation Application. Please note that you must comply with the following directions within **fourteen days** of the date of this letter. **If you cannot comply with the below directions within fourteen days, you must inform the Registrar immediately at Registrar@oeb.ca.**

You are directed:

1. To conduct a search of title forthwith sufficient to identify the current registered property owners, those who hold encumbrances on the lands, and those with any interest in the lands directly affected by the expropriation application.
2. To immediately serve the following documents either personally, by courier, or by registered mail on all parties discovered through the title search directed in paragraph 1 above, as property owners and affected encumbrancers:

- a) The English and French versions of the Notice and the application; and
 - b) Property descriptions, aerial maps and survey plans showing the details of the proposed expropriations.
3. To file with the OEB in both hard copy and electronic form affidavit evidence proving service in accordance with paragraphs 1 and 2 immediately after service is effected, with a copy of the complete Notice, application, and original post office registration receipts (where applicable) or courier confirmation lists attached as appendices.

Note: The affidavit of service referred to above must confirm that those served are all those identified as having a direct or registered interest in the lands directly affected by the expropriation application.

- 4. To immediately, or as soon as it is ready, have a copy of both the English and French versions of the Notice and the non-confidential version of the application made available for convenient public perusal at NextBridge's office.
- 5. To post a copy of the both the English and French versions of the Notice and non-confidential version of the application in a prominent place on NextBridge's website.
- 6. To immediately provide a copy of the English or French version of the Notice and a non-confidential version of the application to any person upon request.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
