**Re: EB-2018-0130 Cost Claim – Follow-up**

We are in receipt of Ms. Wong's follow-up email correspondence dated June 12, 2019, (attached as Appendix A) in relation to the cost claim of Anwaatin Inc. (**Anwaatin**) filed on May 28, 2019. We trust that the following explanations satisfy Ms. Wong's follow-up requests in relation to Anwaatin's cost claim in the Proceeding.

We filed Anwaatin's letter of intervention (the **Letter**) via the Regulatory Electronic Submission System on Thursday, December 20, 2018, just prior to the close of business (reference number: 36700). We were therefore unable to send a hard copy of the Letter to the Board on the same day. The person in our office who handles couriers was out of the office on Friday, December 21, and the hard copy of the Letter was therefore sent out on Monday, December 24. We sent the Letter via UPS as our usual courier service, Good Foot Delivery, was unavailable on December 24. As Tuesday, December 25 and Wednesday, December 26 were statutory holidays, it appears that UPS did not deliver the Letter until the next business day (Thursday, December 27).

We confirm that the UPS receipt included in the cost claim (tracking number: 1ZV5572RDH85454983) corresponds to the delivery of the Letter. We made no electronic submissions to the Board of any kind whatsoever on Friday, December 21, 2018, and are therefore unable to explain why Anwaatin's letter of intervention in the Proceeding appears twice in the WebDrawer, albeit with distinct file names. We note that the file names for each of the two entries in the WebDrawer indicate a date of December 20, 2018.

We trust that these explanations will satisfy the Board and respectfully request a full award of eligible costs.
