

Enbridge Gas Inc.

**Application for leave to construct natural gas pipelines and
associated facilities to serve the Georgian Sands planned
subdivision in Simcoe County**

PROCEDURAL ORDER NO. 2

June 18, 2019

Enbridge Gas Inc. (Enbridge Gas) applied to the Ontario Energy Board (OEB) under sections 90(1) and 97 of the *Ontario Energy Board Act, 1998* for leave to construct approximately 8 metres of Extra High Pressure and approximately 6.4 kilometres of Intermediate Pressure natural gas pipelines and associated facilities to serve the Georgian Sands planned subdivision in Simcoe County. Enbridge Gas has also applied to the OEB for approval of the form of land use agreements related to the construction of the proposed project.

The OEB issued a Notice of Hearing on March 27, 2019. Anwaatin Inc. (Anwaatin) applied for intervenor status and cost eligibility. No objection was received from Enbridge Gas.

In Procedural Order No. 1 issued on April 25, 2019, the OEB approved Anwaatin as an intervenor and made provision for interrogatories and interrogatory responses. Interrogatories were filed by OEB staff and Anwaatin on May 9, 2019 and responded to by Enbridge Gas on May 23, 2019.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. OEB staff and Anwaatin shall file any written submissions and serve them on Enbridge Gas by **June 27, 2019**.

2. Enbridge Gas shall file any reply submissions and serve them on all other parties by **July 9, 2019**.

All filings to the OEB must quote the file number, EB-2018-0226 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a USB flash drive in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
