**Re: EB-2017-0049 Anwaatin Inc. Cost Claim – Follow-up**


We are in receipt of Ms. Wong's follow-up email correspondence dated June 24, 2019, (attached as Appendix A) in relation to the cost claim of Anwaatin Inc. (**Anwaatin**) filed on June 13, 2019. We trust that the following explanations satisfy Ms. Wong's follow-up requests in relation to Anwaatin's cost claim in the proceeding:

1. The Staples invoice (#10290335) filed in support of the cost claim corresponds to our disbursement for a printed hard copy of Hydro One Networks Inc.'s application in EB-2017-0049, which numbered approximately 5,000 pages. We trust that the highlighted portions of the email correspondence attached as Appendix B are sufficient evidence of the nexus between the Staples invoice and our representation of Anwaatin in the proceeding.
2. We have provided a detailed breakdown and explanation of the courier disbursements claimed on page 4 of 20 of the cost claim in the table attached as Appendix C. In certain cases and when appropriate, courier costs were apportioned equally between Anwaatin and Energy Storage Canada, another cost-eligible intervenor that we represented in the proceeding.
3. The TTC receipt is for disbursements associated with our travel on behalf of Anwaatin to and from the Ontario Energy Board and our offices, which were (at the relevant time)

located at 5 Hazelton Avenue, Suite 200, Toronto, ON M5R 2E1, during the oral hearing phase of the EB-2017-0049 proceeding (approximately June 11, 12, 14, 18, 19, 21, 25, and 28, 2018).

We trust that these explanations will satisfy the Board and respectfully request a full award of eligible costs.
