

**Hydro One Sault Ste. Marie LP**

**Application for electricity transmission revenue  
requirement beginning January 1, 2019 and related  
matters**

**PROCEDURAL ORDER NO. 6  
June 27, 2019**

Hydro One Sault Ste. Marie LP (Hydro One SSM) filed an application with the Ontario Energy Board (OEB) on July 26, 2018 under section 78 of the *Ontario Energy Board Act, 1998, S.O. 1998, c. 15, (Schedule B)*, and under the OEB's *Filing Requirements for Electricity Transmission Applications*. Hydro One SSM is seeking approval for changes to its electricity transmission revenue requirement to be effective January 1, 2019 and related matters.

The OEB issued a Decision and Order on June 20, 2019. The Order set out several procedural steps, including a date of June 27, 2019 for Hydro One SSM to file a draft Revenue Requirement and Charge Determinant Order.

On June 26, 2019, Hydro One SSM filed a letter with the OEB stating that additional time is required to finalize the information related to the clearing of the deferral and variance account balances. Hydro One SSM requested an extension to file a draft Revenue Requirement and Charge Determinant Order to July 2, 2019.

On June 27, 2019, in correspondence with OEB staff, Vulnerable Energy Consumers Coalition (VECC), an intervenor in this proceeding, requested that the date to submit costs claims be extended to July 23, 2019, due to the unavailability of certain VECC staff.

The OEB grants the requested extensions and the revised dates are shown below.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

**THE ONTARIO ENERGY BOARD ORDERS THAT:**

1. Hydro One SSM shall file with the OEB and forward to intervenors a draft Revenue Requirement and Charge Determinant Order and supporting schedules that reflects the OEB's findings in the Decision and Order, no later than **July 2, 2019**. Hydro One SSM shall also include customer bill impacts and detailed information in support of the calculation of the final revenue requirement in the draft Revenue Requirement and Charge Determinant Order.
2. OEB staff and intervenors may file any comments on the draft Revenue Requirement and Charge Determinant Order with the OEB, and forward to Hydro One SSM, no later than **July 9, 2019**. Costs will not be awarded for the review of the draft Revenue Requirement and Charge Determinant Order or for the filing of any comments on the draft Revenue Requirement and Charge Determinant Order.
3. Hydro One SSM shall file with the OEB responses to any comments on its draft Revenue Requirement and Charge Determinant Order no later than **July 15, 2019**.
4. The Association of Major Power Consumers in Ontario, Energy Probe Research Foundation, School Energy Coalition, and Vulnerable Energy Consumers Coalition shall submit their cost claims no later than **July 23, 2019**.
5. Hydro One SSM shall file with the OEB and forward to intervenors any objections to the claimed costs no later than **August 2, 2019**.
6. Intervenors shall file with the OEB and forward to Hydro One SSM any response to any objections for cost claims no later than **August 9, 2019**.
7. Hydro One SSM shall pay the OEB's costs incidental to this proceeding upon receipt of the OEB's invoice.

All filings to the OEB must quote the file number, EB-2018-0218, be made in searchable / unrestricted PDF format electronically through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.oeb.ca/OEB/Industry>. If the web portal

is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
