Kitchener-Wilmot Hydro Inc.

Application for electricity distribution rates and other charges beginning January 1, 2020

PROCEDURAL ORDER NO. 2 June 28, 2019

Kitchener-Wilmot Hydro Inc. (Kitchener-Wilmot Hydro) filed a cost of service application with the Ontario Energy Board (OEB) on April 30, 2019 under section 78 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Kitchener-Wilmot Hydro charges for electricity distribution, to be effective January 1, 2020.

The OEB issued Procedural Order No. 1 on June 20, 2019 that, among other things, set a schedule for various steps in this proceeding.

On June 25, 2019, the Vulnerable Energy Consumers Coalition filed a letter requesting the OEB delay the due date to file written interrogatories. Having considered this request, the OEB extends the date for intervenors to file written interrogatories and for Kitchener-Wilmot Hydro to file its responses to all interrogatories. The revised schedule is below¹. All other dates from Procedural Order No. 1 remain the same².

IT IS THEREFORE ORDERED THAT:

- 1. OEB staff shall request any relevant information and documentation from Kitchener-Wilmot Hydro that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on all parties by **July 5, 2019**.
- 2. Intervenors shall request any relevant information and documentation from Kitchener-Wilmot Hydro that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on all parties by **July 10, 2019**.

² The dates set out in provisions 5-9 of Procedural Order No. 1 (June 20, 2019) remain unchanged.

3. Kitchener-Wilmot Hydro shall file with the OEB complete written responses to all interrogatories and serve them on all intervenors by **July 31, 2019**.

All filings to the OEB must quote the file number, **EB-2019-0049**, be made in searchable/unrestricted PDF format electronically through the OEB's web portal at <u>https://pes.oeb.ca/eservice/</u>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <u>http://www.oeb.ca/OEB/Industry</u>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a USB memory stick in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.

All communications should be directed to the attention of the Registrar at the address below, and be received no later than 4:45 p.m. on the required date.
