
AFFIDAVIT OF GREGORY VAN DUSEN

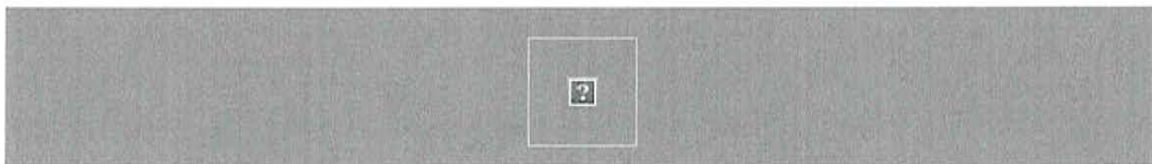
