Re: Certificates of Public Convenience and Necessity
Norfolk County, the County of Elgin and the County of Middlesex
Ontario Energy Board File Number: EB-2017-0108

In its Procedural Order No. 9 issued on June 17, 2019, the Ontario Energy Board directed Enbridge Gas and EPCOR Natural Gas Limited Partnership ("EPCOR") to submit detailed infrastructure maps for Norfolk County and for each of the lower-tier municipalities in the County of Elgin and the County of Middlesex where both utilities have infrastructure that:

- identify its mains (in a manner that allows the OEB to determine which side of the road the mains are on), service lines, district stations and gate stations;
- identify any infrastructure built outside of its currently certificated areas that are necessary to bring natural gas supply to the area but may not be serving any customers; for the purposes of obtaining authorization for this infrastructure, each utility shall state the road that the infrastructure is on, as well as the locations from where the infrastructure begins and ends, as can be seen in the Greenfield South Power Corporation certificate; and
- include a scale, a legend that identifies the different pipelines and stations, and a north arrow

The lower-tier municipalities within the County of Elgin in which both Enbridge Gas and EPCOR have infrastructure are the Municipality of Central Elgin, the Township of Malahide and the Municipality of Bayham. The only lower-tier municipality within the County of Middlesex in which both Enbridge Gas and EPCOR have infrastructure is the Municipality of Thames Centre.

Pursuant to Procedural Order No. 9, the requested maps for Norfolk County (Schedule A1), the Municipality of Central Elgin (Schedule B1), the Township of Malahide (Schedule C1), the Municipality of Bayham (Schedule D1), and the Municipality of Thames Centre (Schedule E1) are to be treated as confidential. Electronic copies will be provided to the OEB and those scheduled to attend the upcoming technical conference that have signed the OEB's Declaration and Undertaking.

With respect to infrastructure built outside currently certificated areas, Enbridge Gas submits the following:

Norfolk County

In its Decision and Order dated October 11, 2018 in this proceeding, the Ontario Energy Board granted CPCN rights to Enbridge Gas in the areas in Norfolk County where it currently has infrastructure to bring it into compliance, including the north half of Lots 3 and 5 in Concession 7, and all of Lots 4 and 5 in Concession 8.

As was noted in a previous submission, Enbridge Gas has determined that the infrastructure that it has in place on Concession Road 8 in Norfolk County is on the Concession 8 side of the road and within Lots 2 and 3 in Concession 8. As a result, although these lots were excluded pursuant to F.B.C. 259, Enbridge Gas submits that these lots should be included in its CPCN for Norfolk County. They are attached to a pipeline that runs along Concession Road 8 between West Quarterline Road and Norfolk County Road 23.

A proposed CPCN for the areas within Norfolk County served by Enbridge Gas is attached as Schedule A2.

Municipality of Central Elgin

Enbridge Gas is not aware of any infrastructure built outside of its currently certificated areas within the Municipality of Central Elgin. A proposed CPCN for the areas within the Municipality of Central Elgin served by Enbridge Gas is attached as Schedule B2.

Township of Malahide

In its Decision and Order dated October 11, 2018 in this proceeding, the Ontario Energy Board granted CPCN rights to Enbridge Gas to supply gas to Lot 24 in Concession 11 in the Township of Malahide. This is the only lot currently served by Enbridge Gas in the Township of Malahide. Enbridge serves four residential customers in the Township of Malahide which are metered by EPCOR. As previously noted, Enbridge Gas will arrange to have these customers directly metered and billed by Enbridge Gas once the new CPCN is finalized for the Township of Malahide.

A proposed CPCN for the area within the Township of Malahide served by Enbridge Gas is attached as Schedule C2.

Municipality of Bayham

Enbridge Gas is not aware of any infrastructure built outside of its currently certificated areas within the Municipality of Bayham. A proposed CPCN for the area within the Municipality of Bayham served by Enbridge Gas is attached as Schedule D2.

Municipality of Thames Centre

Enbridge Gas is not aware of any infrastructure built outside of its currently certificated areas within the Municipality of Thames Centre. However, Enbridge Gas continues to receive several requests for service to locations that would require extensions to its existing infrastructure. A

proposed CPCN for the area within the Municipality of Thames Centre served by Enbridge Gas is attached as Schedule E2.
