**Re: Ontario Sustainable Energy Association – Cost Claim
Board File No. EB-2017-0049**

Please find enclosed the Ontario Sustainable Energy Association's ("OSEA") late cost claim for its contribution in the above-noted proceedings. OSEA apologizes for the late filing of its cost claim and respectfully requests that the Board consider OSEA's cost claim.

OSEA was granted intervenor status and cost award eligibility in this proceeding pursuant to the Board's decision dated November 2, 2017. OSEA was an active participant in this proceeding. OSEA filed interrogatories, attended at the oral hearing and asked questions of various panels, and filed written reply submissions.

In late May 2019, OSEA prepared its cost claim for filing. OSEA did not file its cost claim at that time as there was not yet a procedural order issued requiring intervenors to file their cost claims. OSEA was waiting for the procedural order to file its cost claim.

One of the two lawyers on record for OSEA in this proceeding has been on maternity leave this year (Joanna Vince). The other of the two lawyers on record (Robert Woon) left our firm. The lawyers that took over management of the file (Matt Gardner and Victoria Chai) were not on the distribution list and did not receive the interim rate order issued on June 11, 2019 inviting intervenors to file cost claims. Our legal assistant (Swaberene Baksh) spoke with the OEB in May 2019 to ask when the OEB anticipated issuing an order to submit cost claims in this proceeding and was told that the OEB had not yet issued an order. We reviewed our records and confirm that the interim rate order was sent to Robert Woon's former email address; however, inadvertently, the interim rate order was not then forwarded to Mr. Gardner or Ms. Chai.



For the reasons above, we respectfully request that the Board consider OSEA's cost claim (enclosed).
