Description of current business activities

Jupiter Energy Advisors provides advisory and support services in energy procurement. Jupiter acts as agent or advisor only for its clients. Jupiter assists large-volume energy end-users in the commercial, industrial, and institutional sectors, to develop and implement energy supply plans. Jupiter supports its clients with advice and analysis about the structure of supply portfolios, the negotiation of supplier contracts, the future direction of prices, and the development of energy supply budgets and purchase targets. The company's expertise for electricity cost management includes procurement strategies, load displacement generation, battery storage and demand management. Jupiter also administers supply contracts for its clients and provides invoice verification and cost reporting.

Acting as agent, Jupiter purchases electricity on behalf of its large-volume end-use clients in Ontario including universities, municipalities, school boards and hospitals. Procurement amount, type, term and pricing are predetermined with client approval. All purchases are made via competitive solicitation of the supplier community. From time to time, some of the company's clients are required to sell some of their pre-purchased or self-generated electricity to the market.

Jupiter receives its compensation directly from its clients and does not accept third-party or supplier commissions or compensation.

Jupiter has a staff of 18 people with a broad range of experience in energy supply procurement and management, as well as energy regulation and energy deregulation.
