**Re: Alectra Utilities Corporation ("Alectra")
EB-2019-0018 Application for 2020 Rates
Enbridge Gas Inc. Request For Late Intervenor Status**

We write on behalf of Enbridge Gas Inc. ("Enbridge") to request late intervenor status in this proceeding.

Enbridge is a gas distributor serving more than 3.7 million residential, commercial and industrial customers located throughout Ontario. As a distributor regulated by the Ontario Energy Board ("OEB"), Enbridge has a direct interest in all matters of jurisdiction, practice, procedure and policy related to electricity and gas regulation in Ontario. Enbridge has particular interest in proceedings that affect the way that the OEB regulates and sets rates for regulated utilities.

Enbridge is interested in Alectra's application, particularly the proposal for an "M-Factor", which the OEB describes as a proposal for additional capital funding. The Board's decision on this M-Factor proposal could have implications for other regulated utilities, including Enbridge. As such, Enbridge has a direct interest in this proceeding.

Enbridge intends to participate in this proceeding by reviewing the application and evidence, and reserves the right to ask interrogatories, participate in the technical conference and oral hearing and make submissions as it deems appropriate. Enbridge acknowledges that this proceeding is already underway, and accepts the record as it stands.

Enbridge is not eligible for and does not seek a cost award in this proceeding.

Enbridge requests that the persons noted below be included in the distribution list for any documents, correspondence and updates related to this proceeding.


