Energy Probe Intervenor Request Letter**

Energy Probe Research Foundation (Energy Probe) applies for intervenor status in the EB-2019-0105 proceeding, the application by Enbridge Gas Inc. to the Ontario Energy Board for the approval of disposition of balances in the 2018 deferral and variance accounts and the 2018 utility earnings.

### **Statement of Interest**

Energy Probe is a non-profit environmental and consumer organization which promotes economic efficiency in the use of resources. Energy Probe will be representing its natural gas residential customer supporters in Ontario, which we have some number of thousands, and will also be representing a broader concern with respect to the overall financial health and operational integrity of Ontario utilities.
