Re: EB-2019-0018 – Alectra Utilities Corporation (“Alectra Utilities”) 2020 Electricity Distribution (“EDR”) Rate Application – Alectra Utilities’ Interrogatory Responses

Alectra Utilities Corporation (“Alectra”) is the Applicant in the above-referenced proceeding. In accordance with the Ontario Energy Board’s (the “Board”) Procedural Order No. 1 dated July 9, 2019, parties were required to submit interrogatories on the Applicant’s evidence for the IRM elements by July 29, 2019 with the Applicant’s responses due August 16, 2019.

Enclosed are Alectra’s responses to interrogatories for the IRM elements from Board Staff, Building Owners and Managers Association (“BOMA”), and Energy Probe Research Foundation (“Energy Probe”).

Alectra Utilities has filed responses to the following IRM-related interrogatories for BOMA: BOMA-2; BOMA-3; BOMA-8 and BOMA-9. Alectra Utilities will file a response to BOMA-1 on September 13, as this is a M-factor or Distribution System Plan related question. BOMA did not include questions for BOMA-4; BOMA-5; BOMA-6; BOMA-7; and BOMA-10, and as such, no responses have been filed.

Alectra Utilities has filed responses to the following IRM-related interrogatories for Energy Probe: EP-6; EP-10; EP-15; EP-16; EP-17; and EP-18. Alectra Utilities will file responses to Energy Probe's M-factor or Distribution System Plan related questions on September 13.
