**Re: EB-2019-0195 – Enbridge Application to Amend Certificate of Public Convenience and Necessity (“CPCN”) Rights within Thames Centre and Central Elgin
Intervenor Request Letter of EPCOR Natural Gas Limited Partnership (“ENGLP”)**

ENGLP seeks intervenor status in the above proceeding. ENGLP is a distributor of natural gas in Ontario and is a customer of Enbridge Gas Inc. (“Enbridge”).

ENGLP is an active intervenor in Union Gas Limited’s (now Enbridge’s) application currently before the Ontario Energy Board (“OEB”), OEB File No. EB-2017-0108, with respect to CPCN Rights in Norfolk County, the County of Elgin and the County of Middlesex. Thames Centre and Central Elgin are located within Middlesex County, and as such ENGLP interests in this proceeding align with those previously expressed with respect to its intervention in the EB-2017-0108 proceeding.
