#### Re: EB-2019-0015 - North Bay/Espanola MAADs - SEC Cost Claim

We are counsel for the School Energy Coalition. We enclose the cost claim of the School Energy Coalition, on the Board's form and enclosing docket details.

This case involved an unusual two-stage proposal for what was otherwise a relatively straightforward acquisition of a smaller LDC by a larger one. Although the two stages were necessary in the particular circumstances, it resulted in a complicated interaction of Board policies and regulatory principles. The case included interrogatories, a motion by one of the intervenors, and written argument. As SEC did not participate directly in the motion, time spent was limited to review of the materials in preparation for final argument, and has been included in that category. Counsel Jay Shepherd took the lead for SEC, and time spent by co-counsel Mark Rubenstein assisting in the matter has not been claimed.
