LETTER OF DIRECTION

Dear Mr. Kitchen:

Re: Enbridge Gas Inc. (Enbridge Gas)
Windsor Pipeline Replacement Project

Ontario Energy Board File Number: EB-2019-0172

On August 9, 2019, Enbridge Gas Inc. (Enbridge Gas) applied to the Ontario Energy Board (OEB) under section 90(1) of the *Ontario Energy Board Act, 1998* (Act) for approval to replace approximately 64 kilometres of a natural gas pipeline and associated facilities in the Town of Lakeshore, Town of Tecumseh and the Municipality of Chatham-Kent (Windsor Pipeline Replacement Project). Enbridge Gas also applied to the OEB under section 97 of the Act for approval of the form of land use agreement.

The OEB has now issued its Notice of Hearing for Enbridge Gas' application for the Windsor Pipeline Replacement Project (Notice). The English and French versions of the Notice will be published by the OEB, in accordance with directions to the OEB's agent which were copied to you. Please note that you must comply with the directions in paragraphs 1 through 3 below **prior to September 27, 2019**, which is the publication date of the newspaper in which the Notice will appear last. If you are unable to comply with the directions within this timeframe, you must inform the Registrar immediately at Registrar@oeb.ca.

You are directed:

- 1. To conduct a search of title forthwith, sufficient to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the proposed pipeline and related facilities.
- 2. No later than the date the Notice is posted on Enbridge Gas' website in accordance with paragraph 3, to arrange for the service of each of the enclosed English and French versions of the Notice, in the exact form accompanying this letter and the application and the evidence, directly on each of the following:

- a. All property owners and encumbrancers with lands or interest in lands identified in the search of title referred to in paragraph 1
- b. the clerks of the Essex County, the Municipality of Chatham-Kent, Town of Lakeshore, Town of Tecumseh, and the City of Windsor
- c. all indigenous communities that have been consulted or with lands or interest in the lands directly affected by the proposed pipeline and related facilities
- d. the Métis Nations of Ontario, Lands, Resources and Consultation Office, 66 Slater Street, Suite 1100, Ottawa, Ontario K1P 5H1
- e. all affected utilities, pipelines and railway companies
- f. members of the Ontario Pipeline Coordinating Committee

(Note: It is acceptable to serve a party with an electronic copy of the evidence, provided the party has stated its preference in writing for the same. If you choose to email a party, please request a read-receipt prior to sending the email.)

- To make a copy of both the English and French versions of the Notice, the application and evidence, and any amendments thereto, available for public review at Enbridge Gas' office and in a prominent place on Enbridge Gas' website.
- 4. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 through 3 above, immediately thereafter with the relevant Notices and original post office registration receipts (where applicable), or courier confirmation lists attached as appendices.
- 5. To provide a copy of the Notice, application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
