**Re: Enbridge Gas Distribution Inc. ("Enbridge") and Union Gas Limited ("Union")
Rates for 2008
Board File No. EB-2007-0606/EB-2007-0615**

We are counsel to Coral Energy Canada Inc. ("**Coral**") in the above-mentioned proceeding. Coral hereby requests that the Board grant Coral status as full intervenor in the above-mentioned proceeding.

In this proceeding, the Board has combined the applications of Enbridge and Union for a multi-year incentive rate mechanism to determine rates for the regulated distribution, transmission and storage of natural gas, to be effective January 1, 2008.

Description of Coral

Coral is an affiliate of Shell, which operates in North America as part of the global Shell Trading network which include services in wholesale power and natural gas marketing and trading. Coral operates in Ontario as one of the largest suppliers of natural gas and electricity to commercial and industrial customers, customers include utilities, gas distribution companies, municipalities, rural electrical cooperatives, independent power producers and gas and power aggregators.

Procedure

Coral requests the right to intervene in this proceeding, to appear by or with counsel, to cross-examine on all matters raised during this hearing that may relate to its interests, to adduce evidence on specific matters of its choice related to this application, and to present argument.

Coral's preference is for an oral hearing to ensure that the process allows a complete and thorough review of the issues raised by this proceeding, given its significance to the electricity industry.

Coral requests that the Board, Enbridge, Union and any other intervenors provide it and its counsel with copies of all evidence and correspondence related to this application.

Eligibility for Costs

The state of the application to date is not sufficient to determine whether special circumstances may be present in this proceeding. Coral therefore reserves the right to apply for eligibility should special circumstances arise as this proceeding develops.


