In accordance with the Ontario Energy Board's (OEB) Decision on Settlement Proposal and Procedural Order No. 6, the Independent Electricity System Operator (IESO) is writing to file responses to interrogatories received on its updated evidence on the stopping of further work on the current High Level Design for the Incremental Capacity Auction as part of the Market Renewal Program.

The IESO notes that some interrogatories have raised issues which the IESO believes to be beyond the scope of this proceeding or the OEB's Decision on Settlement Proposal and Procedural Order No. 6. The IESO has, in these cases, provided responses in an effort to be of assistance to the parties. The fact that the IESO has provided an answer to these interrogatories should not be taken as any indication that the IESO considers these areas of enquiry to be appropriate at this stage of the revenue requirement proceeding.
