RE: Consultation to Review Natural Gas Supply Plans – Extension Request

Ontario Energy Board: EB-2019-0137

On September 26, 2019, the Ontario Energy Board (OEB) received a letter from the Federation of Rental-housing Providers of Ontario (FRPO) requesting that the OEB provide additional time for stakeholders to submit their written comments on Enbridge Gas Inc.'s (Enbridge) gas supply plan and for Enbridge to submit its written response. Specifically, FRPO is requesting that the October 7, 2017 deadline for stakeholder comments be extended to October 21, 2019 and the October 21, 2019 deadline for Enbridge's written response be extended to November 18, 2019.

The OEB grants the extensions. Stakeholders are to submit written questions on Enbridge's gas supply plan by **October 21, 2019.** Enbridge is to submit its written comments and/or revision statement by **November 18, 2019**.

Cost Awards

The eligible hours per participant for stakeholder's written comments on Enbridge's gas supply plan will be up to 15 hours.

All filings to the OEB must quote the file number, EB-2019-0137 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at https://pes.ontarioenergyboard.ca/eservice/. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at https://www.oeb.ca/industry. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a USB flash drive in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
