LETTER OF DIRECTION

Dear Mr. Ott:

Re: Enbridge Natural Gas Inc. Owen Sound Reinforcement Project Leave to Construct and Rate M17 Ontario Energy Board File Number: EB-2019-0183

The OEB has issued a Notice of Hearing for Enbridge Gas Inc.'s application for leave to construct approximately 34 kilometres of 12 inch diameter natural gas pipeline and associated facilities located in the Municipality of West Grey, the Township of Chatsworth both in the County of Grey and for approval of a new firm transportation service for gas distributors under Rate M17 (Notice). The Notice will be published by the OEB, in accordance with directions to the OEB's agent which were copied to you. Please note that you must comply with the directions in paragraphs 2 and 3 below **prior to October 10, 2019**, which is the publication date of the newspaper in which the Notice will appear last. If you are unable to comply with the directions within this timeframe, you must inform the Registrar immediately at <u>Registrar@oeb.ca</u>.

You are directed:

 To conduct a search of title forthwith, sufficient to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the proposed pipeline and related facilities.

- 2. No later than the date the Notice is posted on Enbridge Gas Inc.'s website in accordance with paragraph 4, to arrange for the service of the enclosed Notice, in the exact forms accompanying this letter, and the application and the evidence, directly on all property owners and encumbrancers with lands or interest in lands identified in the search of title referred to in paragraph 1 above.
- 3. No later than the date the Notice is posted on the Enbridge Gas Inc.'s website in accordance with paragraph 4, to arrange for the service of the enclosed Notice, in the exact form accompanying this letter and the application directly on the following:
 - a. the clerks of the Municipality of West Grey, the Township of Chatsworth, the County of Grey, Municipality of Arran-Elderslie, the Municipality of Kincardine, and the Township of Huron-Kinloss
 - all Indigenous communities that have been consulted or with lands or interest in the lands directly affected by the proposed pipeline and related facilities
 - c. the Métis Nation of Ontario, Lands, Resources and Consultations Office, 66 Slater Street, Suite 1100, Ottawa, Ontario K1P 5H1
 - d. all affected utilities, pipelines and railway companies
 - e. members of the Ontario Pipeline Coordinating Committee
 - f. all Enbridge Gas Inc.'s customers that are currently taking or eligible to take service under Rates M17, M9 and/or T3
 - g. the clerks of all municipalities in which Enbridge Gas Inc. supplies gas
 - h. all natural gas distributors in Ontario, including, EPCOR Southern Bruce Gas Inc., EPCOR Natural Gas Limited Partnership, Six Nations Natural Gas and City of Kitchener
 - i. all intervenors in EB, 2018-0244 and EB-2018-0305.

- 4. To make a copy of the Notice, the application and evidence, and any amendments thereto, available for public review at Enbridge Gas Inc.'s office and in a prominent place on Enbridge Gas Inc.'s website.
- 5. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 through 4, immediately thereafter.
- 6. To provide a copy of the Notice, the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
