Re: **Corporation of the Town of Marathon
North Shore LNG Project
Ontario Energy Board File Number: EB-2018-0329**

The Ontario Energy Board (OEB) is in receipt of the intervention request letter you filed on behalf of your client, Anwaatin Inc. (Anwaatin), dated October 17, 2019 (Letter).

Anwaatin is an Indigenous business corporation that focusses on:

- i. Access to efficient electricity and natural gas energy solutions for indigenous communities
- ii. Ensuring Indigenous communities have reliable energy transmission and distribution services in order to meet basic needs and facilitate economic development
- iii. Addressing poor electricity reliability and the disparate and adverse impacts that it has on Indigenous communities and Aboriginal rights
- iv. Strengthening distributed energy resources in Indigenous communities to facilitate resilience and efficient electrification solutions to address climate change

Anwaatin states that its member Indigenous communities for this proceeding include, “subject to further confirmation”, Aroland First Nation and Animbiigoo Zaagi igan Anishinaabek. It further states that “additional Indigenous communities identified in the Application may also be included among Anwaatin’s Indigenous members in this proceeding”.

Based on the language of the Letter, it is not clear to the OEB Panel exactly who Anwaatin represents with respect to the current proceeding. It is also not clear what direct interest these parties may have in the applications that comprise this proceeding:

- a) A leave to construct application
- b) Applications for several certificates of public convenience
- c) Applications for municipal franchise agreements
- d) An application for approval of the form of certain easement agreements
- e) An application for approval of a gas supply plan
- f) An application for pre-approval for the cost consequences of a long term gas supply contract

Absent this information, the OEB will not accept Anwaatin as an intervenor. If Anwaatin would like to file additional information for the OEB’s consideration, it shall do so by **October 24, 2019**.
