Additional Cost Claim of Vulnerable Energy Consumers Coalition (VECC)

On January 14, 2019 on behalf of the Vulnerable Energy Consumers Coalition (VECC) the Public Interest Advocacy Centre (PIAC) filed a cost claim with respect to the above-noted proceeding.

The Decision and Order came out on March 18, 2019 and the cost claim PIAC filed in January has already been paid in full by both Enbridge Gas Inc. (20,668.23 July 18, 2019) and Epcor Utilities Inc. (49.61 April 23, 2019).

It has just been brought to our attention that only the invoice portion of the consultant firm (ECSI) relating to proceeding EB-2017-0255 in the amount of 18,105.43 was actually attached and filed with the VECC cost claim.

The invoice portion relating to EB-2017-0224 was never received from the consulting firm by the Public Interest Advocacy Centre (PIAC) and therefore never included with the original cost claim. It just came to light yesterday when the Consulting Firm was reviewing their outstanding invoices and realized they had never sent it to PIAC Administrator in January for submission and they inadvertently missed it possibly due to:

"There was so much going on at that time and we were in the midst of moving our office."

We are asking that the Board accept the attached additional cost claim with respect to the abovenoted proceeding. The Consultant on the file was very diligent in submitting her invoices for submission and we believe the companies would know she was an active participant in the proceeding. We apologize for all the inconvenience this may cause and ask for leniency in the granting and approval of VECC Additional Cost Claim.
