**Enbridge Gas Distribution Inc. 2007 Test Year Rate Case Notice of Application dated September 7, 2006**

We are submitting this letter on behalf of our client, the Industrial Gas Users Association ("IGUA"), in response to an Application by Enbridge Gas Distribution Inc. ("EGD") dated August 25, 2006.

- 1. IGUA applies for intervenor status in these proceedings.
- 2. IGUA is an association composed of industrial users of substantial quantities of gas distributed by Ontario gas distributors. IGUA members currently consume 144 Bcf of gas per annum, of which approximately 80 Bcf is consumed in Ontario. The members of IGUA are vitally concerned with the supply and price of gas and all other matters directly or indirectly affecting supply and prices. IGUA has appeared in previous proceedings before this Board involving EGD.
- 3. The members of IGUA, which carry out their industrial undertakings in the Province of Manitoba, Ontario and Québec, are listed in Schedule "A" hereto.
- 4. IGUA intends to consider and address all of the issues which the Board eventually lists for determination in these proceedings.
- 5. IGUA's preference is for an oral hearing on the grounds that an oral hearing is the most cost-effective manner for considering the issues that EGD's Application raises.



- 6. IGUA intends to seek an award of costs from EGD with respect to its participation in these proceedings on the grounds of its long standing status as an intervenor determined by the Board to be eligible for an award of costs.
