To OEB Board Secretary,

Speaking as an intervenor on file EB-2018-0270, I think it would be beneficial to hear about (or I would like to speak to) the cumulative negative effect of the ongoing costs to Hydro One customers as a result of Orillia Power and Orillia Distribution Corporation's decisions, lobbying and offloading of costs for their corporate profit.

I was employed for 36 years at the Orillia Water Light and Power Commission, under Frank Kehoe, Gord Davidson and John Mattinson, as well was a councillor in Orillia for 4 years.

In 1998 I watched and objected to the actions of my boss, John Mattinson, that contributed to the break up of Ontario Hydro.

I watched as he formed the Ontario Water Power Association and instructed producers of electricity to dump water over dams so as to cause an electricity shortage of 1 cent/KWH power. As a result, Orillia Power averaged 6cents/KWH from 2002-2008. This adversely affected Hydro One customers not to mention the industrial job losses across the province.

In 2002 I reported to Orillia Council (Councillor Doug Downey) via the Orillia Packet and Times that Ontario was set up for a major blackout due to these and other power manipulations for profit. I was fired. Again Hydro One customers were adversely affected.

The sale of Orillia Power Distribution brings increased costs to Hydro One customers, including the costs associated with building a control hub in Orillia. Orillia is offloading its distribution costs, for corporate profit, at a direct expense to Hydro One customers.

I do not see how this even begins to meet the do no harm requirements. I am optimistically waiting for the OEB "to regulate Ontario's energy utilities in the **public** interest."

I believe an oral hearing is very necessary and I am willing to participate.
