**Re: Upper Canada Transmission, Inc. operating as NextBridge Infrastructure, LP (“NextBridge”)
Ontario Energy Board (“Board”) File EB-2019-0127
East-West Tie Project – Expropriation Application
Refiling of Expropriation Plans – Description of Modifications**

On November 5, 2019, NextBridge filed with the Board Expropriation Plans and stated in its cover letter that in some cases, the lands shown in the plans are slightly reduced from what was originally applied for and approved. In response to a request from the Board, the following table specifies which parcels were modified and describes the modification. For clarity, attached are the original plans that were filed and approved by the Board with written explanations in red font in the affected areas.

7	EWT 9524, F-23 (Grant Lake)	31135-0004	- Portion of Part 1 on the original plan has been removed as the easement area crosses the bed of the Dog River, which is Crown land. (See also Detail A and Part 1 on the second page of the electronically filed current plan named EWT9522_1_Plan_EWT9524_Plans_1_and_2.pdf_Plans_3_4_and_5.pdf)
8	EWT 9013 (and 9014, 9017, 9072), F-19 (Naveau)	31176-0001	- Part 8 on original plan removed. - Part 21 on original plan removed. - Portion of Part 14 on original plan removed as it does not extend to the Michipicoten River (Water Power Location JC 322), i.e. Part 14 is not as long as depicted on the original plan. (See also the electronically filed current plan named EWT9013_Corridor_and_Road_2.pdf)
9	EWT 9522, F-22 (Grant Lake)	31167-0016	None
