Service Area Amendment Application to Amend Hydro One Remote Communities' Distribution Licence In Accordance With Ontario Regulation 199/02

Pursuant to section 74 of the *Ontario Energy Board Act, 1998*, and in accordance with section 1.(2) of Ontario Regulation 199/02 (the "Regulation"), Hydro One Remote Communities Inc. ("Remotes") is requesting an amendment ("SAA") to its distribution licence. This amendment will update Remotes distribution licence to reflect the communities it serves and will update community names, as required.

This request does not encompass all the communities listed in section 1. (1) of the Regulation. As those communities are not currently included in Remotes' licence as of the date of this letter (as they are served by someone other than Remotes) but are listed in the Regulation. When each of those communities are able to satisfy Remotes' transfer requirements and are ready to connect to Wataynikanyap's transmission line (and by extension, the IESO-controlled grid), Remotes will file an application with the Board to make the necessary amendment(s) to Remotes' distribution licence to add those communities to its defined service area at that time.

Because of this amendment, Schedule 1 of Remotes' distribution licence should list the following communities that are already being served by Remotes:
