### 1 TOPIC AREAS OF QUESTIONING

During the oral hearing, OEB staff intends to pose questions to Hydro One Networks Inc. and Orillia Power Distribution Corporation (Applicants) on the below listed five topic areas. In addition, OEB staff may request that the Applicants respond to questions related to potential conditions that could be placed on the post-merger entity.

# 1.1 Topic Area #1: Operational, Maintenance & Administrative (OM&A) and Capital costs

 OEB staff will pursue a line of questioning related to the Applicants' historical and forecast OM&A and capital costs to serve their respective rate classes. As part of this exploration, OEB staff will question the Applicants on their capital plans for the current Orillia Power Distribution Corporation service territory and the potential impact on quality of service and reliability.

Included will be the Applicants' individually developed estimates of status quo and amalgamated scenario costs to serve current Orillia Power Distribution Corporation customers (e.g., goal posts identified in the application).

### 1.2 Topic Area #2: Acquired Rate Classes

 OEB staff will pursue a line of questioning on the need for and the implications of the Applicants' proposal to create acquired rate classes for current Orillia Power Distribution Corporation customers post rebasing deferral period.

# 1.3 Topic Area #3: Responsiveness to Previous OEB Decisions

• OEB staff will seek clarification from the Applicants on how the proposed transaction is responsive to the concerns the OEB expressed in its decision on Hydro One Networks Inc.'s distribution rates<sup>1</sup> application.

## 1.4 Topic Area #4: Cost Allocation and Rate Design

 OEB staff will pursue a line of questioning related to the Applicants' proposed approach to post rebasing deferral period cost allocation. This line of questioning will also explore shared costs.
