**Re: OPG Electricity Generation Licence – EG-2003-0104**

Please accept this letter as notification of changes to the list of licensed generation facilities set out in Schedule 1 of OPG's Generation Licence.

The requested changes to Schedule 1 include deletion of Lambton Generating Station, Nanticoke Generating Station, Unit 1 of Thunder Bay Generating Station, BIC Wind Turbine, Pickering Wind Turbine, and Smokey Falls 1 Generating Station. These stations have been decommissioned. Also, Indian Chute Generating Station has been renamed to Chute Generating Station.

OPG submits the following information on the units that have been decommissioned:

- As of December 31, 2013, consistent with Ontario Regulation 496/07 Cessation of Coal Use – Atikokan, Lambton, Nanticoke and Thunder Bay Generation Stations (Attachment 1), OPG ceased coal fired operations at the following generating stations: Lambton, Nanticoke, and Thunder Bay Unit 1.
- BIC Wind Turbine reached its end of life. The facility went into service in October 1995 and had an estimated operating life of 20 years. In 2016, the BIC Wind Turbine was de-registered and disconnected from Hydro One's distribution system.
- Pickering Wind Turbine reached its end of life. The facility went into service in 2001. The turbine stopped working due to damage and the cost to replace the

turbine's older parts was too high. The facility was disconnected in October 2019, from the local distribution system, Veridian Connections /Elexicon Energy.

- Smokey Falls 1 Generating Station has been de-registered (Attachment 2, 3).

Additionally, minor editing changes have been made to Schedule 1 List of Licensed Generation Facilities (pages 27-28) of the Licence, such as correcting river systems and spelling of facility names. Supporting documentation including a red-line version is attached (Attachment 4, 5).

OPG proposes that the Board dispose of this proceeding without a hearing, in accordance with section 21(4)(b) of the *Ontario Energy Board Act, 1998*. OPG submits that the requested changes to Schedule 1 of OPG's Generator Licence have not materially impacted any other party.
