### **Foreword to Marathon's Response**

Marathon's responses to all of Anwaatin's interrogatories herein reflect the limited scope of Anwaatin's participation in this proceeding as set out in the Ontario Energy Board's (the "Board") Procedural Order No. 2 dated October 30, 2019, namely: the impacts on communities that Anwaatin directly represents (Aroland First Nation, Animbiigoo Zaagi'igan Anishinaabek Nation, and Ginoogaming First Nation, together, the "**Anwaatin First Nations**"), and to the issues that are within the scope of the applications currently before the OEB, with a particular focus on items that are directly related to impacts of the North Shore distribution development.

**Question: Anwaatin.1**

Preamble: Assessment of alternatives is a core principle of the *Environmental Assessment Act*, RSO 1990, c. E.18 and most environmental assessment processes applicable to pipelines and pipeline project approvals.

Alternatives assessment in Canada generally includes (i) evaluating impacts on Indigenous rights and interests and (ii) assessing impacts of construction and operation on environmental and cultural heritage features, prior to determining a preferred alternative.

- (a) Please provide all evidence that the Municipalities and/or their consultant(s) considered and developed — and the results of any and all — assessments of alternatives, including, but not limited to, (i) evaluating impacts on Indigenous rights and interests, (ii) assessing impacts of route evaluation and selection, construction, and operation on environmental and cultural heritage features, and (iii) assessing impacts on the potential future expansion of service to other communities — First Nations and other municipalities.

### **Response**

- (a) Stantec Consulting Ltd. ("**Stantec**") undertook environmental studies on behalf of each Municipality to determine the preferred location of the Project, having regard to Indigenous rights and interests, environmental, cultural heritage features and socio-economic factors, and to recommend mitigation and protection measures applicable to the construction and operation of the Project. The studies were also undertaken to meet the requirements of relevant federal and provincial environmental guidelines and regulations.

The environmental study and alternatives assessment proceeded in three phases:

- Phase 1: The route evaluation and selection process.
- Phase 2: The identification of a preliminary preferred route and preferred LNG storage depot site location.

- Phase 3: Confirmation of the route and LNG storage depot and preparation of the environmental reports ("**ERs**").

The environmental study commenced with the notification of Indigenous communities and the Métis Nation of Ontario, including, but not limited to, the communities listed on the Ministry's letter to Marathon dated May 21, 2019 (the "**Duty to Consult Letter**"), and as further described in Appendix B1 of the ER of each Municipality. Both Animbiigoo Zaagi'igan Anishinaabek Nation and Ginoogaming First Nation were notified in this regard. Correspondence sent to Indigenous communities requested information on impacts that the Project may have on constitutionally protected Aboriginal or treaty rights and measures for mitigating those impacts. The Municipalities and their consultants considered and took into account the matters described in this question as set out in the ERs that are incorporated by reference in the application at Exhibit A, Tab 10, Schedule A, Attachments 1a-1e.

Please note that as the distribution system proposed for each Municipality will be installed, for the most part, in previously disturbed municipal road allowances, assessment and evaluation of route alternatives was not a focus of the ERs.

Preamble: Indigenous governments commonly provide proponents of infrastructure and resource development projects with principles and procedures for conducting consultation and accommodation, and similar guidance for archaeological assessment processes on their traditional territories.

- (a) Please provide all information on or related to the Municipalities' consideration and implementation of any such principles and procedures.

**Response**

- (a) Stantec, on behalf of the applicant Municipalities, designed and employed procedures with regards to the duty to consult and accommodate, including as described in the Board's *Environmental Guidelines for Hydrocarbon Pipelines and Facilities in Ontario*, 7th Edition (2016) (the "**Environmental Guidelines**"), in conjunction with relevant government ministries, and through the consultation experience of Stantec, which has included the consideration of such principles and procedures.

The objectives of such consultation involve:

- The identification of interested and potentially affected parties early in the process;
- Informing and educating interested parties about the nature of the Project, potential impacts, proposed mitigation measures and how to participate in the consultation program in a clear, concise, relevant and timely manner;
- Providing a forum for the identification of issues;
- Identifying how input will be used in the planning stages of the Project;
- Summarizing issues for resolution and resolve as many issues as feasible;
- Revising the program to meet the needs of those being consulted, as feasible; and
- Developing a framework for ongoing communication during the construction and operation phase of the Project.

The implementation of these procedures is further detailed in Sections 3.2-3.6 of each Municipality's ER.

**Question: Anwaatin.5**

Preamble: The majority of First Nations in Ontario do not have access to natural gas, and many First Nations are interested in accessing natural gas for energy cost savings and low-emission heating. The *Access to Natural Gas Act, 2018*, SO 2018, c 15 (Bill 32) provides a framework for regulations to deliver rate protection for consumers or prescribed classes of consumers with respect to costs incurred by natural gas distributors in making a qualifying investment for the purpose of providing access to a natural gas distribution system to those consumers by reducing the rates that would otherwise apply in accordance with the prescribed rules.

- (a) What impacts will the Municipalities' project have on the provision of natural gas to Indigenous reserve communities and off-reserve members in the region?
- (b) What impacts will the Municipalities' project have on the cost of natural gas to Indigenous reserve communities and off-reserve members in the region?
- (c) What impacts will the Municipalities' project have on the electrical distribution and transmission systems in the local region, given that natural gas for heating will displace electricity for heating?
- (d) What impacts will the Municipalities' project have on have on opportunities for applications of renewables and distributed energy resources (DERs) in the region?

**Responses**

- (a) The reserve communities of the Anwaatin First Nations are not within the areas to be served by the Project. Off-reserve members that live or have businesses within the Project area will have the potential to access natural gas services from the proposed utility in the same manner as all other residents and businesses.
- (b) If the Project were to be extended to areas beyond the five (5) Municipalities in order to serve certain Indigenous reserve communities, residents in these communities would have access to an energy source, the cost of which would be materially less than existing sources of energy. See the responses to SEC-13(a)-(d) and OEB Staff-10(c).
- (c) As described in Exhibit A, Tab 4, Schedule 3, given that forecast conversion rates from electricity to natural gas among residential, commercial, institutional and industrial customers are consistently among the lowest for all fuel types in the region, it is not anticipated that the Project will have a material impact on the electrical distribution and transmission systems in the local region.
- (d) There is potential for renewable natural gas ("**RNG**") as an alternative supply source for the natural gas distribution system. At this time, the Municipalities have not done a feasibility analysis to collect, treat and compress the RNG into the natural gas distribution

system. However, the Municipalities will investigate potential RNG sources within their respective communities to determine if any of these sources are feasible prior to the next 5-year comprehensive natural gas plan update and will report any feasible supplies in the annual plan updates.

Preamble: The Municipalities engaged the Ministry of Energy, Northern Development and Mines (the **Ministry**) to determine if there is a duty to consult requirement triggered by the project (Exhibit A, Tab 1, Schedule 2, p. 6).

- (a) Please describe and provide copies of any and all communications and responses between the Municipalities and the Ministry with respect to the delegated duty to consult and accommodate First Nations and Métis communities.
- (b) Please indicate whether the Ministry has communicated with the Municipalities with respect to whether it is satisfied that Indigenous consultation and accommodation related to the application is sufficient.

**Responses**

- (a) The applicant Municipalities are committed to fostering positive and productive relationships with all Indigenous rights-holders groups, including First Nations and Métis communities. The Municipalities have engaged with First Nations and Métis communities to build an understanding of project-related interests, ensure regulatory requirements are met, mitigate or avoid project impacts, and provide mutually beneficial opportunities.

On March 18 and 19, 2019, Marathon provided a study commencement letter regarding the North Shore Project to the Ministry, Ontario Pipeline Coordinating Committee members, Indigenous groups, and other stakeholders. The letter described the Project and the environmental study process, provided a map of the five Municipalities showing the preferred route and the location of the proposed LNG storage depot, and the details for the information sessions and project contact details. In addition, the letter requested information on planning principles or guidelines that may affect the Project, background environmental and socio-economic information, and other developments proposed in the area. The letter to agencies requested information regarding planning principles or guidelines implemented by the agency that may affect routing, construction, and/or operation of the proposed pipeline. The letter also requested background environmental, socio-economic, and archaeological/cultural heritage information. The letter sent to Indigenous communities requested information on impacts that the Project may have on constitutionally protected Aboriginal or treaty rights and measures for mitigating those impacts. Generic copies of these letters are attached at Appendix B3 of the ERs.

On May 21, 2019, Marathon and Stantec received correspondence from the Ministry in response to Marathon's above-noted study commencement letter, by which the Ministry, representing the Crown, delegated the procedural aspects of consultation to the Municipalities (i.e., the "Duty to Consult Letter"). The following First Nation and Métis communities were included in the Duty to Consult:

- Batchewana First Nation;
- Biigtigong Nishnaabeg (Pic River First Nation);
- Biinjitiwaabik Zaaging Anishinaabek;
- Bingwi Neyaashi Anishinaabek;
- Garden River First Nation;
- Ginoogaming First Nation;
- Long Lake #58 First Nation;
- Métis Nation of Ontario (MNO) Superior North Shore Métis Council;
- Michipicoten First Nation;
- Pays Plat First Nation;
- Pic Moberg First Nation;
- Red Rock Indian Band; and
- Red Sky Métis Independent Nation.

On behalf of the Municipalities, Stantec performed community engagement with Indigenous communities, with, but not limited to the First Nation and Métis communities noted in the Duty to Consult Letter, via letters, email, phone calls, and face-to-face meetings with representatives of these Indigenous communities. Through these engagement activities, representatives of the applicant Municipalities have provided an overview of the Project, responded to questions and interests, and reviewed input and concerns expressed by Indigenous communities.

Stantec undertook an environmental study of the construction and operation of the natural gas pipeline, which meets the intent of the Environmental Guidelines. This report was provided to various Indigenous communities, including all identified First Nations and Métis communities included in the Duty to Consult Letter.

The Municipalities will continue to engage with Indigenous communities, including all identified First Nations and Métis communities, in open and transparent dialogue concerning the Project. The Municipalities will continue to offer meaningful opportunities for the exchange of information, responding to inquiries, and hearing and responding to any interests and concerns that may arise, including those related to potential economic and business opportunities.
