Please provide the latest investment levels incurred to date by ICM project.

Oakville Hydro indicates the three road widening projects (Spears, Trafalgar & William Halton Pkwy) are planned to be completed in 2019.

The timing for these projects is determined by the applicable road authority and Oakville Hydro has no control over the pacing of the expenditures.

- a) Please discuss when Oakville Hydro first determined it would require ICM funding for each of these projects.
- b) Please provide the total project schedule length, start date and current completion date for each of the road widening projects as determined by the Town and Region.
- c) Please provide the total project schedule length, start date and in-service date related to Oakville Hydro's work for each of these projects.

- b) Please provide a copy of any subsequent internal DSPs.
- c) Please provide Oakville Hydro's latest 5-year capital expenditure plan.

Please provide a detailed cost breakdown for each of the ICM projects and the costs spent to date under each line item.

- a) Please provide the contingency amounts for each of the ICM projects.
- b) Please provide the contingency amounts used to date and forecast to be spent by the end of the year by project.

Please provide business case for each of the ICM projects.

AMPCO-11

With respect to the Bronte TS feeder project, Oakville Hydro noted that it would not have sought approval for any ICM funding had the road widening projects been deferred, as the incremental revenue

requirement associated with the project would have fallen below its materiality level.
