CLAIM FOR COSTS**

At the invitation of the Board we are hereby submitting the *Claim for Costs* of the *Fallis Group of Intervenors*, being the first submission that the Board has requested from the date of the Filing of this Application on March 29th, 2007, over 14 months ago. The *Claim for Costs* covers the first period from that Application date to May 16th, 2008

We attach at this time with this letter the following;

1. **Appendix "B" - Form 1: Summary of Hours-Consultants and Legal Counsel** for legal counsel Peter T. Fallis, duly completed. (Please note that the form has been enlarged to allow for split tariff rates applicable before and after November 16th, 2007 for functions carried out before and after that date)
2. **Appendix "B" - Form 1: Summary of Hours-Consultants and Legal Counsel** for legal counsel Alec M. McLennan, duly completed. (Mr. McLennan was retained by Mr. Fallis to represent the Fallis Group of Intervenors in respect of attendance required in October 2007 in advance and at the Technical Conference as Mr. Fallis was otherwise engaged in the Court of Appeal of Ontario on an Appeal; on October 15th and 16th, 2007). Detailed dockets for Mr. McLennan are outlined on pages 6 & 7 of the Fallis Dockets attached.

3. **Appendix "B" - Form 2: Summary of Disbursements** duly completed
4. **Appendix "B" - Form 3: Affidavit in Support of Costs Claim** of Peter T. Fallis, duly sworn.
5. **Time Dockets of Fallis Fallis & McMillan from April 2007 to August 20, 2007:** These dockets were jointly kept for Access (EB-2007-0051) & Leave to Construct, (EB-2007-0051). The Access costs Claim was submitted on August 20th, 2007 and subsequently settled. The Leave portion of those Dockets are part of the Costs Claim now submitted and consist of 10 pages, aggregating **41.35 hours** of time spent in respect to this Application, Leave to Construct, (EB-2007-0051)
6. **Time Dockets of Fallis Fallis & McMillan from August 20, 2007 to May 16, 2008.** These Dockets are very comprehensive, include the October time docketing records of Alec M. McLennan for his October 2007-services, consist of 25 pages plus a summary page that will assist in understanding the accounts. (Please note that the Costs Tariff changed on November 16th, 2007 and results in different numeric rate extensions as the services performed straddle that calendar date.
7. **Accommodation Receipts:** There are three receipts enclosed for 12 nights of Toronto Accommodation @ \$75.00 a night, which is a most reasonable expense. (*One further night receipt for February 21, 2008 is missing and when located will be forwarded as an additional claim*).
8. **Parking:** Parking is claimed for 15 calendar days including both Mr. McLennan and Mr. Fallis. The initial rates in 2007 were \$13.00 a day but increased to \$16.00 a day when automatic pay kiosks were established. Receipts are missing for several of the days. The costs are reasonable nevertheless, and will be well understood by Board Staff assessing this claim.
9. **Meals:** This writer does not believe in submitting meal claims as an expense. As he would eat at home on his own nickel, the expense merely replicates that expenditure that would otherwise be personally made by him.
10. **Travel:** Travel has been claimed @ \$.40 per KM for each trip from Durham to either Toronto (190 km one way-380 KM round trip) or Orangeville (95 KM one way or 190 round trip).
11. **Telephone.** This is a very real expense and one which could be claimed if accurate records were kept or a sophisticated records system were installed. As it stands that expenditure is borne out of the tariff rate paid. Mr. McLennan has claimed \$28.55 for his telephone costs.
12. **Copy Charges:** The charges are for recorded copies only, The boxes of files maintained by us in this matter suggest to us that actual copies made would probably be the triple of the recorded claim. We however restrict our cost recovery for copies just to the recorded entries at the accepted rate of \$.25 per copy.
