Receipt for \$75.00 for accommodation.

I did not obtain receipt as the opportunity presented itself as a much cheaper option than \$200 a night for downtown hotel accommodation plus taxes, I did not include taxi charges either to the hearing offices in Toronto which approximated \$28.00. If you are not prepared to allow the payment, that is fine, but in the future I will stay at a regular hotel and obtain a receipt. The ultimate Payor, HONI will not benefit from the savings generated.

Receipt for \$50.00 hall rental.

I represent about 38 individual landowners who are intervenors in both applications EB 2007 0050 (Leave to Construct) and EB 2007 0051 (Access). I do not represent a group. Rather than having separate meetings with all 38 intervenors I felt that there would be an obvious efficiency in hosting one general meeting at which all client intervenors could attend. I did not have space in my Office to accommodate those numbers and I rented a neighbouring Church Hall from the Durham Presbyterian Church for \$50.00 at which most of the 38 individual intervenor clients attended. Enclosed is a copy of my cheque for \$50.00 in payment of that rent.

I trust this is a sufficient explanation. To meet individually with the intervenors would have added at least another 16 hours to our account which saved the ultimate payor. HONI. from such expenditure.
