IN THE MATTER OF the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), (the "Act")

AND IN THE MATTER an Application by Hydro One Networks Inc. Pursuant to section 98 of the Act, for an interim Order granting access to land in connection with the Applicant's request for leave to construct a new transmission line between the Bruce Power Facility and the Milton Switching Station

COSTS SUBMISSIONS OF "FALLIS GROUP"

1. The 'Fallis Group' consist of those Land Owner Interveners in OEB Applications EB-27-0050 and EB 2007 who retained the law firm of Fallis Fallis & McMillan, of Durham, ON, (the 'Solicitors'), to act for each individual Intervener, w ho originally consisted of those Interveners listed in Schedule 'A' to these Costs Submissions as attached hereto.
2. The Original Interveners who are marked with an (*), are land owners who subsequently advised Fallis Fallis & McMillan on or about June 15th , 2006 that they were changing solicitors and would be retaining other solicitors who represented members of an ad hoc organization called "*Powerline Connections*"
3. The OEB has advised the Solicitors that each of the listed members in Schedule 'A', and on whose behalf the Solicitors recognition of Intervention, would be eligible for costs entitlement in due course.
4. Each of the individual Interveners, now known as the 'Fallis Group, and on whose behalf the solicitors continue to act, have not incurred any additional recoverable expense other than the legal expenses of the Solicitors, which Solicitors costs are apportioned equally among each of those individual Interveners so represented by the Solicitors.

Entitlement to an Award of Costs

5. The Solicitors have set out as Schedule "B" hereto a copy of the 9 page *Docket Sheet* maintained by the Solicitors for the Fallis Group which accurately details the time spent and the expenses incurred in respect to both the *Leave to Construct Application* (No. EB-2007-0050) and the *Application for Access to Land*, (No. EB-2007-0051). Time only has been apportioned between the two OEB Files, as noted on the *Docket Sheets*. The costs incurred have not, however, been apportioned between the two Applications, and in fact have been now included with *Billing Invoice* associated with the Fallis Group for the *Access to Land Application*

6. The contribution of the Solicitors and the Fallis Group to the *Access to Land* proceedings (EB-2007-0051), as well as the *Leave to Construct* proceedings (EB 2007-0050) have been most valuable and of assistance to all parties and landowners. The specific achievements of the Fallis Group include the following at the Motion hearings heard in Toronto on June 25th, 2007:
 - i. Achieving from the OEB a postponement of the Leave to Construct hearings from October 22nd, 2007 to January 14th, 2008
 - ii. Achieving an Order from the OEB requiring *HONI* to provide each Landowner with a scaled photobase map showing the line location on the photos and allowing any owner, on special written request to obtain a copy of the entire set of over 400 photo base maps covering the Bruce to Milton Proposed 500 KV Transmission Line.
 - iii. Achieving a recognition from the OEB that it will permit the proposed 500 KV transmission line route through the Town of Hanover to be explored through the interrogatory phase of the Hearing
 - iv. Achieving a statement from the OEB that it expected *HONI* to provide a list of their witnesses and their qualifications in advance of the Access to Land hearings
 - v. Achieving a delay in the Issues Conference from July 17th, 2007 to September 10th and the issues day from August 2nd to September 17th, 2007, the last day for filing Interrogatories from August 13th, 2007 to October 30th, 2007, and the last day for filing intervener evidence from September 18th, 2007 to November 27th, 2007.

- vi. Obtaining an Order of the OEB to move the hearings out of Toronto to be held in Orangeville Ontario
 - vii. Obtaining an Order permitting Interveners to recover costs at various milestone stages in Application EB-2007-0050, namely November 2007, February 2008 and after arguments are complete.
 - viii. The Solicitors obtained the elimination of the 10 day Limitation period for filing a *Letter of Intervention*, following the delivery of *Notice*, in late April 2007, in respect of each of the two Applications, *Leave to Construct Application* (No. EB- 2007-0050) and the *Application for Access to Land*, (No. EB-2007-0051).
 - vi. Additionally the Solicitors were successful in receiving OEB clarification as to three important issues:
 1. The OEB denied Interveners a right to, lead evidence about ‘alternate routes’ on the ‘*Leave to Construct*’ *Application*
 2. The OEB denied a request to provide a list of the names and addresses of landowners adjacent to but outside of the proposed 175-200 foot easement taking.
 3. The OEB refuses to consider any lands outside the proposed *HONI* Easement as candidate lands for the ‘*Leave to Construct*’ *Application*’
7. The Solicitors undertook a comprehensive cross examination of the witnesses introduced at the hearing of the *Access to Land Application*, (No. EB-2007-0051) heard at Orangeville on July 30th and 31st, 2007, and made significant detailed and informed argument to the Board, particularly as it related to compensation entitlements otherwise owed to the Landowners, including the Fallis Group, in the event of an Order made by the OEB permitting *HONI* to access the over 400 parcels of lands as owned by various Landowners
8. Success resulting from the Hearing on July 30th and 31st, 2007 was limited, but the evidence introduced through the cross-examination was most insightful and success included the following:
- i. A realization by the OEB and *HONI* that any Order granted by the OEB for access to the land of any landowner was limited in its exercise to the 175 foot or 200 foot strip only for which Leave to Construct was sought, and had no effect or authority beyond the strip, and did not permit *HONI* to obtain access to the Strip through the

adjacent easement lands now utilized by *HONI* nor across the other lands of any Landowner, except with the express permission of such Landowner given on such terms of consideration that *HONI* and such Landowner may otherwise agree.

- ii. A refusal by the OEB to pay the landowner for the limited access right removed from the Landowner by the OEB and given by the OEB to *HONI* on a determination by legal reasoning adopted by the OEB that such access did not constitute a “taking” of a partial interest in land within the meaning of the “*Expropriations Act*”. (The Fallis Group does not agree with the legal rationale of the OEB on this point).
- iii. The OEB learned of the “deemed- generation” clause in the Contract between Bruce Power and the OPA dated October 17th, 2007 which was reviewed by the Auditor General of Ontario who exposed that the Consumers of Ontario may suffer a cost penalty of \$.063 per Kilowatt/hour of \$63.00 per Megawatt/hour for each hour of deemed generation that Bruce Power can produce but cannot transmit after December 31st, 2011 without an additional 500KV of transmission capacity being constructed by *HONI* from the Bruce to Milton by that date, a cost which if delayed will represent over \$96,850 an Hour, over \$2,325 million a day, over \$16.25 million a week, over \$70 million a month, and over \$ 845 million a year.
- iv. The OEB also learned that the OPA and/or *HONI*, on the direction of the Minister of Energy, delayed 1 year, 5 months, 12 days before initiating an Application for Leave to Construct to the OEB from October 17th 2005 when the OPA signed a contract with Bruce Power to construct the 500 KV Line from the Bruce to Milton, until it formally made its application to the OEB on March 29th, 2007. That delay, expressed in deemed-generation dollars represents over \$1.225 Billion
- v. although other interveners were present and made submissions, some in person and

some through counsel, only the Ross Firm and the Solicitors took major active roles for their respective client interveners in the conduct of the hearing on behalf of their Respondent Intervenors.
