Application for rates and other charges to be effective January 1, 2020

1 INTRODUCTION AND SUMMARY

Through this Decision and Rate Order, the Ontario Energy Board (OEB) approves the distribution rate application filed by Hydro One Networks Inc. (Hydro One Networks) for new rates effective January 1, 2020. The application relates to the rates requested by Hydro One Networks for the legacy service areas of the former Norfolk Power Distribution Inc. (Norfolk Power), the former Haldimand County Hydro Inc. (Haldimand County Hydro) and the former Woodstock Hydro Services Inc. (Woodstock Hydro).

The legacy Norfolk Power service area consists of approximately 19,000 residential and commercial customers in the Towns of Simcoe, Port Dover, Delhi, and Waterford, the Village of Port Rowan, and Townsend and Woodhouse Townships. In the EB-2013-0187 proceeding, the OEB approved the acquisition of Norfolk Power by, and the transfer of Norfolk Power's distribution system to, Hydro One Networks. In that proceeding, the OEB accepted Hydro One Networks' proposal to defer the rebasing of the consolidated entity for a five-year period, effective and implemented on September 8, 2014.

The legacy Haldimand County Hydro service area consists of approximately 21,000 residential and commercial customers in the municipal boundary of Haldimand County. In the EB-2014-0244 proceeding, the OEB approved the acquisition of Haldimand County Hydro by, and the transfer of Haldimand County Hydro's distribution system to, Hydro One Networks. In that proceeding, the OEB accepted Hydro One Networks' proposal to defer the rebasing of the consolidated entity for a five-year period, effective and implemented on July 1, 2015.

The legacy Woodstock Hydro service area consists of approximately 16,000 residential and commercial customers in the City of Woodstock. In the EB-2014-0213 proceeding, the OEB approved the acquisition of Woodstock Hydro by, and the transfer of Woodstock Hydro's distribution system to, Hydro One Networks. In that proceeding, the OEB accepted Hydro One Networks' proposal to defer the rebasing of the consolidated entity for a five-year period, effective and implemented on October 31, 2015.

As a result of the OEB's findings in this Decision:

- With respect to the Norfolk Power service area, there will be a monthly total bill increase before taxes of \$0.89 for a residential customer consuming 750 kWh, effective January 1, 2020.
- With respect to the Haldimand County Hydro service area, there will be a monthly total bill increase before taxes of \$0.35 for a residential customer consuming 750 kWh, effective January 1, 2020.

- With respect to the Woodstock Hydro service area, there will be a monthly total bill increase before taxes of \$0.32 for a residential customer consuming 750 kWh, effective January 1, 2020.

Hydro One Networks has also applied to change the composition of the distribution service rates for the Haldimand County Hydro and Woodstock Hydro service areas. For the Norfolk Power service area, the final upward adjustment, exceeding the mechanistic adjustment alone, was made in Hydro One Networks' 2019 application¹ for the Acquired Utilities and therefore the distribution rates have already transitioned to a fully fixed structure.

Residential distribution service rates have historically included a fixed monthly charge and a variable usage charge. In 2015, the OEB issued a policy to transition these rates to a fully fixed structure over a four-year period beginning in 2016.² The Haldimand County Hydro and Woodstock Hydro service areas, however, required a transition period of greater than four years. This is the fifth, and final year of the Haldimand County Hydro and Woodstock Hydro service areas transition to fully fixed rates for residential customers. There is no longer a variable usage rate for this class of customer. This policy change does not affect the total revenue that distributors collect from residential customers.

2 THE PROCESS

This Decision is being issued by delegated authority, without a hearing, under section 6 of the *Ontario Energy Board Act, 1998* (the OEB Act).

The OEB follows a standardized and streamlined process for hearing incentive rate-setting mechanism (IRM) applications filed under the Price Cap Incentive Rate-setting option (Price Cap IR). This process also applies to applications solely implementing the mandated rate design transition, and other pass-through charges. In each adjustment year of a Price Cap IR term, the OEB prepares a Rate Generator Model that includes, as a placeholder, information from the distributor's past proceedings and annual

reporting requirements.³ A distributor will then review and complete the Rate Generator Model, and include it with its application.

Hydro One Networks filed its application on August 19, 2019 under section 78 of the OEB Act and in accordance with the Chapter 3 of the OEB's [Filing Requirements for Incentive Rate-Setting Applications](#) (Filing Requirements) and [Addendum to Filing Requirements for Electricity Distribution Rate Applications](#).

The application was supported by pre-filed written evidence and a completed Rate Generator Model. During the course of the proceeding, the applicant responded to OEB staff questions through emails and phone calls and, where required, updated and clarified the evidence.

3 ORGANIZATION OF THE DECISION


In this Decision, the OEB addresses the following issues, and provides reasons for approving or denying Hydro One Networks' proposals relating to each of them:

- Price Cap Adjustment
- Retail Transmission Service Rates
- Group 1 Deferral and Variance Accounts
- Residential Rate Design

In the final section, the OEB addresses the steps to implement the final rates that flow from this Decision.

This Decision does not address rates and charges approved by the OEB in previous proceedings which are not part of the scope of an IRM proceeding (such as specific service charges⁴ and loss factors). No further approvals are required to continue to include these items on a distributor's Tariff of Rates and Charges.

4 PRICE CAP ADJUSTMENT

The OEB-approved merger, amalgamation, acquisition and divestiture (MAADs) applications for each respective Acquired Utility froze base rates for a five-year period. The five-year period for the Norfolk Power service area began September 8, 2014. For the Haldimand County Hydro and Woodstock Hydro service areas, the five-year period began on July 1, 2015 and October 31, 2015, respectively.

The OEB's decision in Hydro One Networks' 2018-2022 distribution rate application stated:

Hydro One may apply to the OEB using the Price Cap IR approach to be applied to the current rates for the Acquired Utilities, to take effect at the end of each respective deferred rebasing period.⁵

Given that the five-year distribution rate freeze ended on September 7, 2019 for the Norfolk Power service area, Hydro One Networks seeks to increase rates effective January 1, 2020, based on a mechanistic rate adjustment using the OEB-approved ***inflation minus X-factor*** formula applicable to Price Cap IR applications. The components of the Price Cap IR adjustment formula applicable to Hydro One Networks are set out in Table 4.1, below. Inserting these components into the formula results in a 1.55% increase to the Norfolk Power service area's rates: ***1.55% = 2.00% - (0.00% + 0.45%)***.

The inflation factor of 2.00% applies to all Price Cap IR applications for the 2020 rate year.

The X-factor is the sum of the productivity factor and the stretch factor. It is a productivity offset that will vary among different groupings of distributors. Subtracting the X-factor from inflation ensures that rates decline in real, constant-dollar terms, providing distributors with a tangible incentive to improve efficiency or else experience declining net income.

The productivity component of the X-factor is based on industry conditions over a historical study period and applies to all Price Cap IR and Annual IR Index applications for the 2020 rate year.

The stretch factor component of the X-factor is distributor specific. The OEB has established five stretch factor groupings, each within a range from 0.00% to 0.60%. The stretch factor assigned to any particular distributor is based on the distributor's total cost performance as benchmarked against other distributors in Ontario. The most efficient distributor would be assigned the lowest stretch factor of 0.00%. Conversely, a higher stretch factor would be applied to a less efficient distributor (in accordance with its cost performance relative to expected levels) to reflect the incremental productivity gains that the distributor is expected to achieve. The stretch factor assigned to Hydro One Networks is 0.45%.

Findings

The OEB finds that Hydro One Networks' request for a 1.55% rate adjustment for the Norfolk Power service area is in accordance with the annually updated parameters set by the OEB and the OEB's decision in Hydro One Networks' 2018-2022 distribution rate application. The adjustment is approved, and the Norfolk Power service area's new rates shall be effective January 1, 2020.

The adjustment applies to distribution rates (fixed and variable) uniformly across all customer classes.⁹

5 RETAIL TRANSMISSION SERVICE RATES

Distributors charge retail transmission service rates (RTSRs) to their customers in order to recover the amounts they pay to a transmitter, a host distributor, or both, for transmission services. All transmitters charge Uniform Transmission Rates (UTRs) to distributors connected to the transmission system. Host distributors charge host-RTSRs to distributors embedded within the host's distribution system. Each of these rates are OEB-approved.

The Haldimand County Hydro and Norfolk Power service areas are partially embedded within Hydro One Networks' distribution system. Hydro One Networks is requesting approval to adjust the RTSRs that it charges its customers in the legacy service areas to reflect the rates that it pays for transmission services included in Table 5.1 and Table 5.2.

The Woodstock Hydro service area is transmission connected. Hydro One Networks is requesting approval to adjust the RTSRs that it charges its customers in the Woodstock Hydro service area to reflect the rates that it pays for transmission services included in Table 5.1.

Hydro One Networks settles transmission charges on an overall basis and cannot provide the associated transmission demand details separately by rate zone. Therefore, Hydro One Networks proposes to update the RTSRs by using the latest UTRs and Hydro One Networks sub-transmission rates while using the IESO billing information and billing quantities as per the most recent distribution rate applications filed with the OEB by the three Acquired Utilities.¹² A proposal similar to this was approved by the OEB in each of Hydro One Networks' 2017-2019 rate applications for the three Acquired Utilities.¹³

Findings

Hydro One Networks' proposed adjustment to its RTSRs for the three legacy service areas is approved. The RTSRs were adjusted based on the current host-RTSRs and the UTRs current at the time of the filing.

The differences resulting from the approval of new 2020 UTRs will be captured in Accounts RSVA – Retail Transmission Network Charge 1584 and Retail Transmission Connection Charge 1586.

6 GROUP 1 DEFERRAL AND VARIANCE ACCOUNTS

In each year of an IRM term, the OEB will review a distributor's Group 1 deferral and variance accounts in order to determine whether their balances should be disposed.¹⁴ OEB policy requires that Group 1 accounts be disposed if they exceed (as a debit or credit) a pre-set disposition threshold of \$0.001 per kWh, unless a distributor can justify why balances should not be disposed.¹⁵ If the balance does not exceed the threshold, a distributor may elect to request disposition.

In April 2018, the OEB began an inspection of the compliance of the RPP settlement process and the assessment of the deferral and variance account allocation methodology for the main Hydro One Networks distribution business and the three Acquired Utilities. The audit report was published on March 4, 2019.¹⁶

Hydro One Networks states that the most appropriate way to dispose of the account balances is to establish the total balance and seek OEB approval to dispose of the accounts for all four entities in the same year (Hydro One Networks main distribution service area, and the three Acquired Utilities). In response to an OEB staff question, Hydro One Networks clarified that total Group 1 deferral and variance account balance and the allocation between Hydro One Networks and the Acquired Utilities will be presented in both applications for 2021 rates (i.e. Hydro One Networks' 2021 Custom IR update and the Acquired Utilities' 2021 Price Cap IR adjustment.)¹⁷

Hydro One Networks is not proposing to dispose of the 2018 Group 1 account balances at this time for the reason stated above and because the total balance for Hydro One Networks and the three Acquired Utilities is below the OEB's disposition threshold of \$0.001 per kWh.¹⁸

Findings

The OEB finds that no disposition is required at this time, as the disposition threshold has not been exceeded and the utility did not request disposition. The OEB also accepts Hydro One Networks' planned disposition approach for 2021 rates.

7 RESIDENTIAL RATE DESIGN

Some residential distribution rates currently include a fixed monthly charge and a variable usage charge. The OEB's residential rate design policy stipulates that distributors will transition residential customers to a fully fixed monthly distribution service charge over a four-year period, beginning in 2016.¹⁹ The Haldimand County Hydro and Woodstock Hydro service areas are in a transition period that is greater than four years, and are required to continue with this transition until the monthly service charge is fully fixed.

The OEB expects an applicant to apply two tests to evaluate whether mitigation of bill impacts for customers is required during the transition period. Mitigation usually takes the form of a lengthening of the transition period. The first test is to calculate the change in the monthly fixed charge, and to consider mitigation if it exceeds \$4. The second is to calculate the total bill impact of the proposals in the application for low volume residential customers (defined as those residential RPP customers whose consumption is at the 10th percentile for the class). Mitigation may be required if the bill impact related to the application exceeds 10% for these customers.

Haldimand County Hydro Service Area

The OEB's decision in EB-2015-0259 approved the implementation of the transition to fixed rates for the Haldimand County Hydro service area over a five-year period for rate mitigation measures. For this area, Hydro One Networks' fifth step of the implementation of the transition results in an increase to the fixed charge of \$3.75. The bill impacts arising from the proposals in this application, including the fixed rate change, are below 10% for low volume residential customers.

Woodstock Hydro Service Area

The OEB's decision in EB-2015-0271 approved the implementation of the transition to fixed rates for the legacy Woodstock Hydro service area over a five-year period. For this area, Hydro One Networks' fifth step of the implementation of the transition results in an increase to the fixed charge of \$3.45. The bill impacts arising from the proposals in this

application, including the fixed rate change, are below 10% for low volume residential customers.

Findings

The OEB finds that the proposed 2020 increase to the monthly fixed charge for the legacy Haldimand County Hydro and Woodstock Hydro service areas are calculated in accordance with the OEB's residential rate design policy. The results of the monthly fixed charge, and total bill impact for low consumption residential consumers demonstrate that no mitigation is required. The OEB approves the increase as proposed by the applicant and calculated in the final Rate Generator Model. The distributor has now completed its transition to a fully fixed rate structure for residential customers for the Acquired Utilities.

8 IMPLEMENTATION AND ORDER

This Decision is accompanied by a Rate Generator Model and a Tariff of Rates and Charges for each of the three service areas (Schedule A).

Model entries were reviewed in order to ensure that they are in accordance with the last cost of service decision for each of the three Acquired Utilities²⁰, and to ensure that the 2019 OEB-approved Tariffs of Rates and Charges, as well as the cost, revenue and consumption results from 2018, are as reported by Hydro One Networks to the OEB.

The Rate Generator Models were adjusted, where applicable, to correct any discrepancies. The Rate Generator Models incorporate the rates set out in the following table.

Each of these rates is a component of the “Regulatory Charge” on a customer’s bill,

established annually by the OEB through a separate, generic order. The RRRP, WMS and CBR rates were set by the OEB on December 20, 2018.²¹

The Smart Metering Entity Charge is a component of the “Distribution Charge” on a customer’s bill, established by the OEB through a separate order. The Smart Metering Entity Charge was set by the OEB on March 1, 2018.²²

RESIDENTIAL SERVICE CLASSIFICATION

This classification applies to a customer's main place of abode and may include additional buildings served through the same meter, provided they are not rental income units. Residential includes Urban, Suburban and Farm customer's premises which can be occupied on a year-round and seasonal basis. Farm applies to properties actively engaged in agricultural production as defined by Statistics Canada. These premises must be supplied from a single phase primary line. The farm definition does not include tree, sod, or pet farms. Services to year-round pumping stations or other ancillary services remote from the main farm shall be classed as farm. Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable. In addition, the charges in the MONTHLY RATES AND CHARGES - Regulatory Component of this schedule do not apply to a customer that is an embedded wholesale market participant.

It should be noted that this schedule does not list any charges, assessments or credits that are required by law to be invoiced by a distributor and that are not subject to Ontario Energy Board approval, such as the Global Adjustment and the HST.
