Energy Probe Research Foundation (Energy Probe) applies for intervenor status in the EB-2019-0037 proceeding, the application by Greater Sudbury Hydro Electricity Inc. to the Ontario Energy Board for approval of electricity distribution rates effective May 1, 2020.

Statement of Interest
