Application to Amend Upper-Tier Franchise Agreements**

Attached is an Application by Enbridge Gas Inc. for Orders of the Ontario Energy Board with respect to amended franchise agreements with the District Municipality of Muskoka, the Regional Municipality of Waterloo, the County of Grey, the Regional Municipality of Niagara, the Regional Municipality of Peel and the Regional Municipality of York.

While reviewing franchise agreements held by both legacy Union Gas and legacy Enbridge Gas Distribution, it was determined that the Model Franchise Agreements approved by the OEB (which were attached to municipal bylaws) for 6 upper-tier municipalities are in the form to be used for lower-tier municipalities.

The Model Franchise Agreement for upper-tier municipalities contains the following provision of service clause:

2. To provide gas service

The consent of the Corporation is hereby given and granted to the Gas Company to distribute, store and transmit gas in and through the Corporation and to the inhabitants of those local or lower tier municipalities within the Municipality from which the Gas Company has a valid franchise agreement for that purpose.

The Model Franchise Agreement for lower-tier municipalities contains the following provision of service clause:

2. To provide gas service

The consent of the Corporation is hereby given and granted to the Gas Company to distribute, store and transmit gas in and through the Municipality to the Corporation and to the inhabitants of the Municipality.

Since none of these 6 franchise agreements are up for renewal within the next few years, Enbridge Gas is requesting that the Ontario Energy Board approve corrections to the provision of service clause in each of these franchise agreements.

As is noted in the application, each of these upper-tier municipalities has agreed to the proposed amendment.

AND IN THE MATTER OF an Application by Enbridge Gas Inc. for an Order amending existing franchise agreements with the District Municipality of Muskoka, the Regional Municipality of Waterloo, the County of Grey, the Regional Municipality of Niagara, the Regional Municipality of Peel and the Regional Municipality of York.

APPLICATION

1. Enbridge Gas Inc. ("Enbridge Gas"), a regulated public utility, is a corporation incorporated under the laws of the Province of Ontario, with its offices in the City of Toronto and the Municipality of Chatham-Kent.
2. The **District Municipality of Muskoka** is an upper-tier regional municipality in Central Ontario that extends from Georgian Bay in the west, to the northern tip of Lake Couchiching in the south, to the western border of Algonquin Provincial Park in the east. The District Municipality of Muskoka was established by Provincial Legislation and commenced operation effective January 1, 1971. The lower-tier municipalities within the District Municipality of Muskoka are the Town of Bracebridge, the Town of Gravenhurst, the Town of Huntsville, the Township of Georgian Bay, the Township of Lake of Bays and the Township of Muskoka Lakes.
3. Enbridge Gas and its predecessors began distributing natural gas within the Town of Gravenhurst in 1956, within the Town of Bracebridge and the Town of Huntsville in 1958, and within the former Township of Muskoka (now part of the Town of Bracebridge and the Town of Gravenhurst) in 1959. Enbridge Gas does not currently provide natural gas within the Township of Georgian Bay, the Township of Lake of Bays or the Township of Muskoka Lakes.
4. Enbridge Gas has Franchise Agreements¹ with and a Certificate of Public Convenience and Necessity ("CPCN")² for each of the District Municipality of Muskoka, the Town of Gravenhurst, the Town of Bracebridge and the Town of Huntsville.
5. The **Regional Municipality of Waterloo** is an upper-tier regional municipality located in Southern Ontario that consists of the cities of Cambridge, Kitchener and Waterloo, and the townships of North Dumfries, Wellesley, Wilmot and Woolwich. The Regional Municipality of Waterloo was established by Provincial Legislation and commenced operation effective January 1, 1973.

The **County of Grey** is an upper-tier municipality located in Southwestern Ontario that consists of the City of Owen Sound, the Municipality of West Grey, the Municipality of Meaford, the Township of Georgian Bluffs, the Municipality of Grey Highlands, the Town of Hanover, the Township of Southgate, the Town of The Blue Mountains and the Township of Chatsworth.
9. Enbridge Gas and its predecessors began distributing natural gas within the Municipality of Meaford and in the Town of The Blue Mountains in 1957, within the Township of Georgian Bluffs in 1959, within the Municipality of West Grey and the Township of Chatsworth in 1962, within the Town of Hanover and the Township of Southgate in 1963, within the City of Owen Sound in 1977, and within the Municipality of Grey Highlands in 1995.

The consent of the Corporation is hereby given and granted to the Gas Company to distribute, store and transmit gas in and through the Municipality to the Corporation and to the inhabitants of the Municipality.
23. Each of the 6 upper-tier municipalities listed above have agreed to changing this one paragraph (Clause 2) in the currently approved franchise agreements to reflect the clause applicable to upper-tier municipalities. As the amendment does not change the meaning or intent of the original by-laws passed by the municipalities, it appears that, other than the Region of Waterloo, the municipalities have chosen to not issue new by-laws to give effect to the amendment. Correspondence from each of these upper-tier municipalities is attached in Appendix A.
