## **LETTER OF DIRECTION No. 2**

Dear Mr. Sangiuliano:

## Re: Tribute Energy Storage Inc. (TESI) Application for an order to revoke the designation of the natural gas storage areas known as the Bayfield and Stanley 4-7-XI reservoirs Ontario Energy Board File Number: EB-2019-0287

On January 9, 2020, the Ontario Energy Board (OEB) issued a Letter of Direction and Notice of Hearing in the above matter. Per the OEB's Letter of Direction, TESI was required to complete service of the Notice of Hearing by January 15, 2020 and if service was not possible within the noted timeframe, to inform the Registrar. On January 10, 2020, TESI advised the Registrar that it would not be able to complete service of the Notice by January 15, 2020, and requested that the Registrar extend the date for completing service.

Accordingly, the OEB is re-issuing its Notice of Hearing (Revised Notice). The Revised Notice will be published by the OEB, in accordance with directions to the OEB's agent which were copied to you. Please note that you must comply with the directions in paragraphs 2 and 3 below **prior to January 29, 2020**, which is the publication date of the newspaper in which the Revised Notice will appear last. If you are unable to comply with the directions within this timeframe, you must inform the Registrar immediately at <u>Registrar@oeb.ca</u>.

You are directed:

- 1. To conduct a search of title forthwith sufficient to identify the current registered property owners, those who hold encumbrances on the lands, and those with any interest in the lands directly affected by the application;
- 2. To arrange for the service of the enclosed Revised Notice, in the exact form accompanying this letter and the application and the evidence, directly on each of the following:
  - a) All registered intervenors in EB-2011-0076/EB-2011-0077/EB-2011-0078
  - b) All property owners and encumbrancers with lands or interest in lands identified in the search of title referred to in paragraph 1 above
  - c) operators of rail lines, telecommunications or other utilities along or crossing the routes of the affected area
  - d) the Clerks of the Township of Stanley, the Municipality of Bluewater and the County of Huron
  - e) The Métis Nations of Ontario, Lands, Resources and Consultation Office, 66 Slater Street, Suite 1100, Ottawa Ontario K1P 5H1
  - f) The Petroleum Resources Center of the Ministry of Natural Resources and Forestry

(Note: It is acceptable to serve a party with an electronic copy of the evidence, provided the party has stated its preference for the same.)

- 3. To make a copy of the Revised Notice, the application and evidence, and any amendments thereto, available for public review at TESI's office and in a prominent place on TESI's website.
- 4. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 through 3 above immediately thereafter.
- 5. To provide a copy of the Revised Notice, application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
