Re: Utility Remuneration and Responding to Distributed Energy Resources
Board File Numbers: EB-2018-0287 and EB-2018-0288

In September 2019, the Ontario Energy Board (OEB) held a stakeholder meeting to receive input on the objectives, issues and guiding principles for the Utility Remuneration and Responding to Distributed Energy Resources (DERs) initiatives.

The invitation letter for the September stakeholder meeting indicated staff would prepare a report describing the input received and setting out staff's proposals. The letter also indicated stakeholders would be invited to comment on staff's report.

In light of the volume and diversity of stakeholder views, the OEB has decided to provide an additional opportunity for dialogue between staff and stakeholders. OEB staff has prepared a presentation that reports on the input received and sets out its current thinking on scope, including objectives, issues and guiding principles for each initiative. The OEB is inviting interested parties to a stakeholder meeting where OEB staff will:

- summarize input from stakeholder presentations, comments made during the September stakeholder meeting and written comments received
- outline and seek input on staff's current thinking for the scope of each initiative

The OEB is taking this approach to provide an opportunity for participants to hear directly from staff, ask questions, and engage with one another before they submit written comments.

Stakeholder Meeting Details

The stakeholder meeting will be held on **February 20, 2020 from 9:30 a.m. to 3:00 p.m.** It will take place in the OEB's North Hearing Room, 25th floor, 2300 Yonge St., Toronto. The meeting will be webcast to allow remote participation. Meeting details will be sent to registered participants before the meeting date.

Stakeholders who intend to participate in the meeting are asked to email notice of their intention to SectorEvolution@oeb.ca by **February 14, 2020**. Emails should include "EB-2018-0287/0288 February Stakeholder Meeting Attendance" in the subject line and provide the following information:

- Whether the participant intends to attend in person or by webcast

An agenda, along with OEB staff's presentation, will be provided to registered participants at least one week in advance of the meeting. The meeting will be transcribed. All materials related to this meeting will be posted on the OEB's website.

Invitation to Submit Written Comments

Following the meeting, stakeholders are invited to comment on OEB staff's preliminary proposals for each initiative. All interested stakeholders are welcome to submit written comments by **March 20**, **2020**. Filing instructions are included in Attachment A.

Parties must submit electronic copies of filings in searchable/unrestricted Adobe Acrobat (PDF) format through the OEB's web portal at www.pes.ontarioenergyboard.ca/eservice. Parties will need a user ID to make filings through the OEB's web portal. If a party does not have a user ID, visit the "e-filings services" webpage on the OEB's website at www.oeb.ca and fill out a user ID password request.
