Aegent Energy Advisors Inc. (Aegent) has been retained by the Ontario Association of Physical Plant Administrators (OAPPA) to assist OAPPA on matters related to the above-noted application. Therefore, Aegent submits this letter of intervention on behalf of OAPPA.

OAPPA is seeking status as an intervenor in the EB-2006-0034 proceeding and provides the following information:

- 1. OAPPA is a not-for-profit organization whose membership includes physical plant administrators for 17 Ontario universities, a number of whom are customers of the Applicant and will be directly affected by the Ontario Energy Board's decisions on the 2007 Rates Application of Enbridge Gas Distribution Inc. Therefore, this proceeding is of direct interest to OAPPA.
- OAPPA anticipates that it may be active in this proceeding. The precise nature of its intervention
 and the exact matters on which it may focus will be determined by OAPPA once its review of the
 evidence has been completed.
- Should OAPPA move forward with an active intervention, OAPPA expects to seek an award of costs.
- 4. OAPPA's preference would be for an oral hearing. OAPPA considers an oral hearing to be the most effective approach for addressing a comprehensive rates application.
