



# **Enbridge Gas Inc.**

Application for approval to continue the existing financial terms associated with offering Open Bill Access services for the years 2019 and 2020

# PROCEDURAL ORDER NO. 11 January 31, 2020

Enbridge Gas Inc. (Enbridge Gas) filed an application with the Ontario Energy Board (OEB) on December 4, 2018 under section 36 of the *Ontario Energy Board Act*, 1998, for approval to continue the existing financial terms associated with offering Open Bill Access (OBA) services for 2019 and 2020.

In Decision and Procedural Order (PO) No. 8, the OEB approved a partial settlement proposal, which settled on all but two items, and scheduled an oral hearing on the two unsettled items for January 30 and 31, 2020.

At this time, the OEB is making provision for final written argument.

## THE ONTARIO ENERGY BOARD ORDERS THAT:

- 1. Enbridge Gas shall file its argument-in-chief with the OEB and forward it to all parties by **February 7, 2020**.
- 2. Intervenors and OEB staff shall file any submissions on Enbridge Gas' argument-in-chief with the OEB and forward them to all parties by **February 21, 2020**.
- Enbridge Gas shall file its reply argument with the OEB and forward it to all parties by March 6, 2020.

All materials filed with the OEB must quote the file number, EB-2018-0319, be made in a searchable/unrestricted PDF format and sent electronically through the OEB's web portal at <a href="https://pes.ontarioenergyboard.ca/eservice">https://pes.ontarioenergyboard.ca/eservice</a>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name,

postal address and telephone number, fax number and email address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <a href="https://www.oeb.ca/industry">https://www.oeb.ca/industry</a>. If the web portal is not available parties may email their documents to the address below. Those who do not have computer access are required to file seven paper copies.

All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
