Re: EB-2019-0242 - AMPCO Market Rules Review - SEC Cost Claim

We are counsel to the School Energy Coalition ("SEC"). Attached, please find a copy of SEC's cost claim on the Board's prescribed form with detailed dockets. SEC has not included time spent by cocounsel, Jay Shepherd.

This matter was complex, and required review and consideration of IESO license filings, expert reports, and evidence, on issues that are not usually before the Board. The proceeding also included a three day oral hearing, and a further day and a half of oral arguments.

For the purposes of the Board's form we have included time in the 'Other Conference – Preparation' category for time docketed for items that do not fall within the other categories (i.e. filing Notice of Intervention, procedural matters, reviewing submissions on cost eligibility, the stay motion, and reviewing the Board's cost eligibility, stay and final decisions, etc.).

We have also included time spent in preparation of the oral argument under the 'Argument' category, and time spent at the hearing for the oral argument under the 'Oral Hearing – Attendance' category.
